## **ORDINANCE NO. 28885**

AN ORDINANCE relating to the Capital Budget; amending the Capital Budget of the City for fiscal years 2023-2024 for recommended budget adjustments and Council-approved capital projects with outstanding balances.

WHEREAS this ordinance will adjust the budgets for departments for the following reasons: (1) transfers to the Capital Budget for Council-approved capital projects with new funding, and (2) other recommended adjustments, which includes costs that were not anticipated at the time of the 2023-2024 Capital Budget Ordinance was adopted, and

WHEREAS this ordinance will increase the 2023-2024 Capital Budget by \$10,447,271, which is funded by grants, existing fund balances, and transfers from other City funds, primarily the General Fund, Fund 1050 Transportation Revenues, and Fund 3210 Real Estate Excise Tax Fund, and

WHEREAS this ordinance is necessary to ensure the execution of capital project commitments and will not negatively impact financial reserves; Now, Therefore,



#### BE IT ORDAINED BY THE CITY OF TACOMA:

That the Capital Budget for the City for the fiscal years 2023-2024 is hereby amended by adopting the proposed modifications as set forth in Exhibit "A" and "Exhibit B," which provides requested budget adjustment amounts, the revised appropriation, and project-by-project detail within each fund, which exhibits are attached hereto and incorporated herein as part of this ordinance; and that the Capital Budget shall be deemed to be and is hereby amended for the recommended budget adjustments, and transfers to the Capital Budget for City Council-approved projects.
