## **SUMMARY AND PURPOSE:**

A resolution setting Tuesday, June 6, 2023, at approximately 5:15 p.m., as the date for a public hearing before the City Council for the purpose of adopting the draft Six-Year Comprehensive Transportation Improvement Program Amended 2023 and 2024-2029.

### **BACKGROUND:**

This Department's recommendation is based on Section 35.77.010 of the Revised Code of Washington (RCW) that provides that the legislative body of each city and town prepare and adopt a comprehensive transportation program for the ensuing six calendar years and annually thereafter pursuant to one or more public hearings, prepare and adopt a revised and extended comprehensive transportation program, and each one-year extension and revision thereof will be filed with the Secretary of Transportation of the State of Washington. Section 35.77.010 of the RCW further provides that each city will include in their comprehensive transportation program how they intend to expend the revenues for non-motorized transportation purposes.

The City adopted the Transportation Master Plan (TMP) in December 2015, which includes a prioritized list of transportation projects. The adoption of the TMP included extensive citywide community outreach, including attendance at neighborhood festivals and clean-ups, and two public hearings. The proposed list of projects to be added to the draft Program supports the goals and policies, as well as network priorities outlined in the TMP.

## **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

Staff provided a presentation to the Infrastructure, Planning, and Sustainability Committee on the proposed list of projects to be added to, removed from, or consolidated with other projects in the draft program on April 12, 2023 and presented the full draft program on May 10, 2023. Staff also provided a presentation to the Transportation Commission on the proposed list of projects to be added to and removed from the draft program on March 15, 2023 and presented the full draft program on May 17, 2023.

## **2025 STRATEGIC PRIORITIES:**

### **Equity and Accessibility:**

This resolution sets the date for a public hearing before the City Council. The public hearing provides residents with the opportunity to comment on planned transportation programs and projects that are vetted for consistency with the TMP, which includes mobility for all modes and abilities with active transportation as the priority.
