



## RESOLUTION NO. 41198

1 A RESOLUTION setting Tuesday, June 6, 2023, upon completion of Regular  
2 Agenda Items, no earlier than 5:15 p.m., as the date for a public hearing by  
3 the City Council on the proposed Six-Year Comprehensive Transportation  
Improvement Program amended for the years 2023 and 2024-2029.

4 WHEREAS Section 35.77.010 of the Revised Code of Washington (“RCW”)  
5 provides that the legislative body of each city and town prepare and adopt a  
6 comprehensive transportation program for the ensuing six calendar years, and  
7 annually thereafter, pursuant to one or more public hearings, as well as prepare  
8 and adopt a revised and extended comprehensive transportation program, and  
9 each one-year extension and revision thereof will be filed with the Secretary of  
10 Transportation of the State of Washington, and

12 WHEREAS the RCW further provides that each city will include in their  
13 comprehensive transportation program how they intend to expend the revenues for  
14 non-motorized transportation purposes, and

16 WHEREAS the City adopted the Transportation Master Plan (“TMP”) in  
17 December 2015, which includes a prioritized list of transportation projects and  
18 included extensive Citywide community outreach, including attendance at  
19 neighborhood festivals and clean-ups, and two public hearings, and

21 WHEREAS the proposed list of projects to be added to the draft Six-Year  
22 Comprehensive Transportation Improvement Program (“Program”) supports the  
23 goals and policies, as well as the network priorities outlined in the TMP, and

That Tuesday, June 6, 2023, upon completion of Regular Agenda Items, no earlier than 5:15 p.m., is hereby fixed as the time, and the City Council Chambers on the First Floor of the Tacoma Municipal Building, 747 Market Street, Tacoma, Washington, and may be offered in a hybrid format that includes a remote option, as the place when and where a public hearing shall be held on the proposed Six-Year Comprehensive Transportation Improvement Program amended for the years 2023 and 2024-2029.
