Dear Mayor and Council Members:

ITEMS OF INTEREST

- 1. The Human Resources department provides the attached **Tacoma Police Department** staffing update for May 20, 2023.
- 2. Planning and Development Services Director Peter Huffman reports that the Planning Commission has completed its review process for the 2023 Annual Amendment to the One Tacoma Comprehensive Plan and Land Use Regulatory Code, which includes six applications. The Commission recommends the City Council deny the proposed Mor Furniture Land Use Designation Change and the Electric Fence Code Amendment, and adopt the proposed Shipping Container Code Amendments, Delivery-Only Retail Standards, Commercial Zoning Update Phase 1 Neighborhood Commercial Nodes, and the Minor Plan and Code Amendments. The City Council will review the Commission's recommendations at the Study Session on June 27, 2023, and conduct a public hearing on the same night to receive public comments. The first and final readings of adopting ordinances are scheduled for the City Council's consideration on July 25, 2023, and August 1, 2023. - 5. <u>City-funded Temporary and Emergency Shelter Performance</u>: The City posts weekly information about its Temporary and Emergency Shelter locations including current census, number of available beds and exits to housing. This information can be found at: https://www.cityoftacoma.org/UserFiles/Servers/Server-6/File/cms/NCS/City%20Authorized%20Emergency%20Shelter%20Sites/Weeklydataupdate.pdf and is updated weekly.
- 6. <u>Encampment Outreach</u>: The City's Homeless Engagement and Alternatives Liaison (HEAL) Team (formerly the Homeless Outreach Team) performs encampment outreach throughout the week to provide individuals opportunities to connect to shelter, behavioral health, substance use and employment services. For the week of May 22 26, 2023, staff visited seventeen locations. This resulted in fifty two individuals being contacted and referred to community services and five individuals accepting shelter.

7. Holy Rosary Safe Parking Site: The safe parking site at Holy Rosary operated by Catholic Community Services (CCS) opened on Monday, April 17, 2023. Site referrals are made through the City's Homeless Engagement and Alternatives Liaison (HEAL) team as well as our contracted partners, Comprehensive Life Resources and Tacoma Rescue Mission Search and Rescue. Since opening six weeks ago, CCS has served 27 individuals and had several positive outcomes including connecting six individuals to permanent housing.

As a reminder, the site is expected to serve up to 40 individuals and/or up to 20 vehicles at a time and expected to provide access to hygiene services such as bathroom, showers, and laundry for residents who are staying on site. The residents also have access to case management to assist with permanent housing solutions.

The City continues to assess operational needs and will be continuing to support CCS and the site's needs as they may arise. CCS hosted its first Community Advisory Committee (CAC) meeting on May 25, 2023. The CAC will meet monthly to review operations and progress of the site, address questions, concerns, and ideas from the public, and provide advisory input. Community members plan to reach out to their neighbors to assess future meeting times and dates and we will share an ongoing date and time when that is established.



LEGISLATIVE INTENT:

Council Contingency Fund Request: The City of Tacoma recognized the Juneteenth holiday for employees in 2022 and we held our first community celebration and inauguration of the Black Lives Matter mural at Tollefson Plaza.

I ask for your support for a Council Contingency Fund expenditure of up to \$7,000 to sponsor the Summer Coding Workshop Series developed by the Lifelong Kindergarten group at the Massachusetts Institute of Technology Media Lab and hosted by Tacoma Public Libraries.

LEGISLATIVE INTENT

Council Contingency Fund Request: The Summer Coding Workshop Series will provide a diverse range of young people in Tacoma with the opportunity to explore and learn how to use a new block-based coding app being developed by the Lifelong Kindergarten group at the Massachusetts Institute of Technology (MIT) Media Lab. The app allows users to take photos and record sounds, and then bring them to life with code.

The Summer Coding Workshop Series will help participants build a wide variety of skills, including learning coding work and creative thinking. During the workshop, participants will create games, stories, and animations to reinforce learning from books read in the Tacoma Public Library Summer Reading Program. Books selected for this workshop will focus on amplifying stories from marginalized communities, including people of color, women, and people with disabilities. This new block-based coding language is set to be officially released in the fall of 2023, giving Tacoma's youth the opportunity to be amongst the first group of people to create using the app.

This contingency fund request would allow the City to sponsor the Summer Coding Workshop Series. This sponsorship would enable Lifelong Kindergarten to purchase twenty 9th Generation iPads for the Summer Coding Workshop Series at an educational price of \$309.00 per iPad and critical accessories. The sponsorship would also include a memorandum of understanding between Lifelong Kindergarten and Tacoma Public Library for the iPads to be donated to the Library after the conclusion of the workshop series. The technology currently available for use at the Tacoma Public Libraries does not allow for patrons to participate in collaborative creative learning activities, such as mobile coding or drawing/animating with tools such as procreate.

In addition, the workshop facilitator, Jaleesa Trapp, grew up in Tacoma and attended Foss High School. She is now a PhD candidate at the MIT Media Lab in the Lifelong Kindergarten Research Group. Her current research focus is developing community-centered creative learning spaces to support marginalized youth and their families.

Notable projects from the Lifelong Kindergarten group include The Computer Clubhouse Network, Scratch, Makey Makey, and Learning Creative Learning. The Summer Coding Workshop Series will focus on reaching a diverse group of participants and reinforcing stories from marginalized communities that are drawn from the Tacoma Public Library Summer Reading Program. In addition, the Summer Coding Workshop Series will grant Tacoma youth the opportunity to be among the first group of people to create using the new app.

When the Summer Coding Workshop Series concludes, the iPads will be made available to be used at all the Tacoma Public Library branches for coding, animation, reading, and other creative learning activities.

Having iPads available for Tacoma Public Library use will allow more young people to participate in library activities in a non-traditional way and may encourage them to explore other resources and activities the library offers. The technology currently available at the Tacoma Public Libraries does not allow for patrons to participate in collaborative creative learning activities, such as mobile coding or drawing/animating with tools such as procreate.

I ask for your support for a Council Contingency Fund expenditure of \$30,000 to support efforts to mitigate the impact of the City's light rail investment for the Hilltop Street Fair and Stadium Business District events.

LEGISLATIVE INTENT

Council Contingency Fund Request: The Hilltop Business District Association (HBDA) is working with a diverse group of stakeholders to hold the Hilltop Street Fair, a widely anticipated and signature community tradition since 2014. This year's Hilltop Street Fair will take place on Saturday, August 26, 2023, from 11:00am—7:00pm. However, physical changes to the event's footprint are needed this year to accommodate the anticipated opening of the Hilltop Tacoma Link Extension (HTLE) of the Sound Transit Tacoma Line.

The HBDA does not currently have the event planning capacity to plan the Hilltop Street Fair on a disrupted footprint while also minimizing disruptions on MLK Jr Way from 9th-14th and 10th and L Street to other adjacent Hilltop locations. This funding is meant to build that capacity. The HBDA needs an event planner with specific logistical, safety, and regulatory planning skills to ensure the City's light rail investment does not unintentionally damage the ability of the Hilltop Street Fair to build and celebrate community.

This contingency fund request would provide a one-time investment of \$30,000 to hire an experienced event planner to work in partnership with the HBDA to adjust the event footprint while also leveraging community assets and promoting use of existing light rail to get to the event. This contingency fund request will also include monies for consultative services to the Stadium Business District for their growing Art and Wine Walk and/or other events that may be impacted by the HTLE rail lines. The impact to these events is likely to be less than the Hilltop Street Fair because Stadium Business District events will be held adjacent to the HTLE rail lines, therefore much of the funding will go toward the HBDA.

Contingency request funding will be used to:

- Advise on event logistics that maximizes community assets, while keeping off MLK and adhere to Sound Transit safety requirements
- Develop a traffic control plan approved by the Permit Office for 2023 and future events
- Create an event how-to manual (digital and hard copy) with tips on best practices such as timelines, so future event planners can replicate the work
- Manage permit process with local government and Sound Transit

- Assist in aligning the event with Sound Transit Grand Opening plans where possible
- Regular check in with community event leaders and assist in communications with the City and Sound Transit
- Load-in and day of event consulting support
- Consultative services to Stadium Business District for Art and Wine Walk/other events

FUNDING REQUESTED:

\$30,000.00

COMMUNITY ENGAGEMENT/ (CUSTOMER RESEARCH):

The Hilltop Street Fair began in 2014, with 5,000 people attending. By 2019, the event had grown, and attendance rose to 25,000. Impacts from community safety measures put the event on hold for 2020 and 2021, and in 2022 when the event was reintroduced, attendance was estimated at 8,000-10,000. The Hilltop Business District Association is working with a diverse group of planning and community members to continue the tradition. Cultural collaboration is important to the event producers and in support of that, The Asia Pacific Cultural Center is a fiscally responsible partner for this event and has shown great support for producing this signature event.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility:

The Hilltop Business District Association (HBDA) is an open organization of businesses, nonprofits, universities, healthcare organizations and hospitals that serve the people of the Hilltop neighborhood in Tacoma. The HBDA believes every person has the right to a safe and welcoming community that values diversity, equity, and inclusion. The HBDA also promotes an environment in which each community member, volunteer, advocate, and employee must have equal access to solving community problems and acting on opportunities. The HBDA values the visible and invisible qualities that make each person who they are and believes a diversity of backgrounds, experiences, and perspectives make a stronger organization. The HBDA is also committed to engaging the community in ways that collectively promote unity and compassion.

The Hilltop Street Fair aims to foster genuine conditions for belonging. Activities included in the Hilltop Street Fair that advance equity and accessibility include:

- People's Park will emphasize international food, culture, immigration and refugees with a global BBQ and offerings by Tacoma's Sister Cities: Korean, Cuban, Chinese, Japanese and Italian recipes.
- Children's activities and dynamic performances on stage by diverse global and local performers.
- Culturally relevant art exhibitions including dancers and costumed entertainers from Latin countries.
- Music stage at 11th and MLK called the 1111 Stage and will feature up and coming local bands from Tacoma and near communities.
- Showcase local artistic talent and organizations such as TUPAC, fashion shows and various bands including Hip Hop.

These types of events and festivals are also economic drivers for local communities, bringing residents and tourists to the Hilltop and Stadium Business Districts, who will patronize local businesses and support the local economy.

Following the event, the event planner will share lessons learned and best practices for improving the event the following year.

Sponsors recommend providing \$30,000.00 to support the Hilltop Street Fair and the Stadium Business District for their growing Art and Wine Walk and/or other events that may be impacted by the HTLE rail lines.
