SUMMARY AND PURPOSE:

A resolution authorizing execution of a Letter of Agreement as negotiated with the International Brotherhood of Electrical Workers, Local 483, Clerical Unit.

BACKGROUND:

The resolution authorizes execution of a Letter of Agreement as negotiated with the International Brotherhood of Electrical Workers, Local 483, Clerical Unit. The Letter of Agreement provides for procedures that may be used by the Public Works, Street Operations Division, during a declared Snow and/or Ice Emergency Event.

At certain times during the year due to snow and/or ice conditions, the City's Public Works Street Operations Division ("Street Operations") may declare a Snow and/or Ice Emergency Event ("Event"), and institute shifts of up to twelve and a half (12 ½) hours for employees, including Financial Assistants (CSC 0504) and Office Assistants (CSC 0060) who work in Street Operations ("Clerical Staff"), to provide necessary services to the City and its population. The City and the Union recognize the unpredictability of such weather Events.

During an event, management may determine the need to change the hours/work shifts for clerical staff outside of the language of the collective bargaining agreement provided in Section 14.5.2. When this occurs, all telework agreements will be suspended, and staff will report to the office during the event. Shift assignments resulting in overtime opportunities for clerical staff will be offered per the terms of the Letter of Agreement.
