October 2023	Create the Charter Review Committee (CRC)
October and November 2023	Receive CRC applications and hold interviews
December 2023	Appoint CRC Members
January - April 2024	CRC meets and creates final report
May 2024	CRC submits final report & recommendations; City Council public hearing; City Council accepts, rejects, or modifies proposed amendments

Early August 2024	Pierce County deadline for ballot titles, explanatory statements, and "For" and "Against" committee appointments

November 5, 2024	General Election



BACKGROUND - 2014

- Charter Review Committee
 - Concerning City Council powers and duties relative to the Public Utility Board (Sections 4.8, 4.12, 4.14, 4.15, and 4.24)
 - * Section 4.18 moved forward, see Proposition No. 6
 - Adopting a new article, "Powers and Responsibilities of the People" (various sections)
 - Requiring financial interest disclosures from certain officers and employees (Section 6.19)

BACKGROUND – 2014



Proposed amendments that the City Council did <u>not</u> move forward to the ballot:

- Charter Review Committee (continued)
 - Expanding City Council authority to hire, appoint, and confirm staff (Sections 3.2 and 3.5)
 * Section 3.4 moved forward, see Proposition No. 5
 - Creating a Citizen Commission on Redistricting (Section 10.14)
