CONSENT AGENDA

Deputy Mayor Campbell moved to adopt the Consent Agenda. Seconded by Council Member Lonergan. Voice vote was taken and carried. The Consent Agenda was declared adopted.

Deputy Mayor Campbell moved to authorize the City's full and final settlement of all violations of the Toxics Substance Control Act alleged by the Environmental Protection Agency relating to used oil management activities at the Tacoma Landfill upon payment by the City in the amount of \$40,000. Purchase Resolution No. 38719

Awarding contracts to:

- Global Contractors, LLC, on its bid of \$367,165.00, sales tax not applicable, plus a 10 percent contingency, for a cumulative total of \$403,881.50, budgeted from the CDBG Fund and the Neighborhood Business District REET Fund, for Business District Sidewalk Improvements in the Dome Business District, McKinley Hill Business District, Pacific Avenue Business District, and install ADA curb ramps at the corners of South 6th and South I Streets Specification No. ED13-0359F; and
- 2. Sage Group Consulting Inc., on its bid of \$292,400.00, plus applicable sales tax, budgeted from the Information Systems Fund, for a four-month contract to conduct a strategic assessment of the City's core Enterprise Resource Planning systems Specification No. IT13-0379F.

Approving the expansion of the Tacoma Water service area by 14.7 acres and authorizing the execution of an agreement to extend the water mains to 15 residents served by the Fennel Heights Maintenance Water System.

Resolution No. 38721

Authorizing the execution and conveyance of a non-exclusive perpetual easement to Robin Bueche, individually and as Successor Trustee of the O'Donnell Family Revocable Living Trust, in the amount of \$10,000, for ingress, egress, and utilities over and across the Tacoma Rail Mountain Division right-of-way in the Ashford area of Pierce County.

Amending Chapter 1.12 of the Municipal Code, relating to the Leave-Based Contribution Plan, to provide eligible employees an opportunity to voluntarily contribute the cash value of accrued vacation and/or personal time off to the United Way of Pierce County.

Ordinance No. 28167 was set over for final reading next week.

Ordinance No. 28168

Amending Chapter 12.08 of the Municipal Code, relating to stormwater and surface water systems, to authorize the Environmental Services Director to establish a pilot program to offer and evaluate the use of rebate payments to eligible customers, in an amount up to \$2,000, who construct and/or maintain City-owned low-impact development rain gardens and bioretention facilities through December 31, 2014

Ordinance No. 28168 was set over for final reading next week.

PUBLIC HEARINGS AND APPEALS

Jameson Babbitt Stites & Lombard, P.L.L.C., representing the appellant H&P Tacoma Acquisition, LLC, by appealing the recommendation of the Hearing Examiner regarding the request to reclassify approximately 1.78 acres/ 75,000 square feet of the southeast corner of a larger property located at 4601 South Orchard Street from a "R-2" Single-Family Dwelling District to a "M-1" Light Industrial District, to be developed with a stormwater detention facility requiring approximately 15,000 cubic yards of grading, landscaping, and up to 100 passenger car parking spaces; and to develop a driveway across the parcel for commercial and passenger vehicle access to South 48th Street. (Paul McCormick, Innova Architects on behalf of H&P Tacoma Acquisition, LLC; File No. REZ2013-40000199731)

Deputy Mayor Campbell moved to continue the appeal hearing to the September 24, 2013, business meeting, at the request of the appellant. Voice vote was taken and carried. The motion was declared adopted.

The appeal was continued to the City Council meeting of September 24, 2013.

REPORTS BY THE CITY MANAGER

City Manager T.C. Broadnax reported that the City of Tacoma Proposition No. 1: A 2% Utility Company Earnings Tax for Tacoma Street Improvements has generated a high level of interest and questions from members of the community about its potential benefits and impacts on neighborhoods, schools, citizens, and businesses. He stated in response to this level of interest, the City of Tacoma is using a similar approach as the budget process to provide facts and information on Proposition No 1 for street improvements by going out to the community and presenting facts and information sessions. He stated the sessions will begin August 26th and last through October 30th on Monday, Wednesday and Thursday evenings for a total of 10 City-wide sessions, with two per Council District. Mr. Broadnax stated the sessions will provide facts and information, will include a five minute video presentation designed to inform citizens of the operational and maintenance issues facing Tacoma and a question and answer period. He then showed the video to the City Council.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Infrastructure, Planning, and Sustainability Committee

Council Member Mello stated the last time he reported out on the Committee was June 25, 2013. He stated since then, the Committee interviewed and recommended applicants for the newly created Transportation Commission and the Sustainable Tacoma Commission, heard a presentation on a potential Rain Gardens program, discussed the expansion of the Tacoma Water Service Area, and the Planning and Development Services departmental work program for 2013-2015. Council Member Mello stated the next meeting of the Infrastructure, Planning, and Sustainability Committee will be Wednesday, August 28, 2013 at 4:30 p.m. to hear a presentation on the Public Works Department's Six Year Transportation Plan.

Council Member Ibsen invited everyone to the following events: the American Credit Union's ribbon cutting, Thursday, August 22, 2013, at 11:30 a.m. at 1965 South Union; the LeMay Foundation Fundraiser, Saturday, August 24, 2013, at 5:30 p.m. at 325 152nd Street East; and Healthy Tacoma's campaign for expanded sick leave on Tuesday, August 27, 2013, in the parking lot at 6th Ave. Photography 2502 6th Avenue.

He stated some of the activities will include music, food, Tall Ships and Argosy cruises; the 5th Annual Stadium District Art and Wine Walk on Saturday, August 24, 2013, from 4:00 p.m. to 9:00 p.m.; Celebrating Military Service Parade on Saturday, August 4, 2013, beginning at 5:00 p.m. in Tollefson Plaza for the 56th Army Bank Concert and at 6:00 p.m., on Pacific Avenue for the parade.
