#### **ITEMS OF INTEREST**

2. On Wednesday, October 2<sup>nd</sup>, there will be two community meetings related to the feasibility of building a new state-of-the-art community center on the eastside of Tacoma. The Program Partner's Forum will be hosted by the City of Tacoma, Tacoma Housing Authority, Tacoma Public Schools, and Metro Parks Tacoma. The community is invited to this forum to share their comments on what types of services are needed in the eastside. The meeting will be held at 3:00 p.m. in the STAR Center - Journey Hall South, located at 3873 South 66<sup>th</sup> Street. In addition, Tacoma Metro Parks will be hosting a Public Open House for public input at 6:30 p.m., at Stewart Heights Pool - Splash Room, located at 402 East 56<sup>th</sup> Street.

#### STUDY SESSION/WORK SESSION

3. The Joint City Council/Parks Board of Commissioners Study Session of Tuesday, October 1, 2013, will be held in Room 16 of the Tacoma Municipal Building North, at Noon. The Joint Study Session discussion item will be: (1) Update on Destination Point Defiance Planning Initiative. Immediately following the Joint Session, there will be a Council Study Session with the following discussion items: (1) North Downtown Subarea Plan and Environmental Impact Statement; (2) Other Items of Interest; (3) Agenda Review; (4) Executive Session – Pending Litigation; and (5) Closed Session – Labor Negotiations.

At Tuesday's Joint City Council/Park Commissioners Study Session, Metro Parks staff will provide an update on the Destination Point Defiance planning initiative. **Destination Point Defiance is a long-term initiative by Metro Parks Tacoma to enhance the experience and honor the character of Point Defiance Park**. Planning for this initiative started in 2005 and included more than 100 community

meetings. The goal of the initiative is to develop a comprehensive plan for Point Defiance Park that focuses on improving access, enhancing activities and stewarding resources.

Immediately following the Joint Study Session during the Council Study Session, Planning and Development Services staff will present a progress report on the development of the North Downtown Sub-Area Plan and Environmental Impact Statement. Key issues that are being addressed include on- and offstreet parking in Stadium, the management of the Stadium Way hillside, and the integration of the LINK extension into the existing urban fabric. This work, taken together with that for Hillside and South Downtown, will complete the sub-area planning work for the Downtown Regional Growth Center.
