TOPICS OF INTEREST

- 2. The 7th Annual South Sound Sustainability Expo on March 1st was a success this year with 950 attendees and a 46% increase from last year. The Expo is a public event intended to provide residents and business owners a place to discover services, products, companies and agencies in the region that address sustainability needs in our community. Sustainability Manager Kristi Lynett provides the attached update which is also available on the City's website.
- 3. The **agenda for the Public Utility Board meeting March 26, 2014**, is attached for your information. Please note item U-10682, adopting specific changes to Tacoma Water's Water Rate and Financial Policy document to facilitate the development of term-limited, market-based wholesale water rates, will be on the Council's April 8th agenda for your consideration.

STUDY SESSION/WORK SESSION

 The City Council Study Session of Tuesday, March 25, 2014, will be held in Room 16 of the Tacoma Municipal Building North, at Noon. Discussion items will be: (1) Legislative Update; (2) Temporary Homeless Camp Permitting Process; (3) Other Items of Interest; (4) Agenda Review and City Manager's Weekly Report, and, (5) Executive Session – Pending Litigation.

At Tuesday's Study Session, Government Relations Officer Randy Lewis will provide Council a legislative update.

In 2010, Washington State law authorized religious organizations to host temporary homeless camps, per RCW 35.21.915, which also allows cities to impose conditions that protect the public health and safety. As a second item at Tuesday's Study Session, Planning and Development Services staff will share an **update on the code development process for temporary homeless camps**, including an overview of the Planning Commission's recommendation and key issues.

COUNCIL REQUESTS/INQUIRIES

- 6. Please see the attached memorandum from Public Works Director Kurtis Kingsolver in response to a question raised by Council Member Ibsen after the February 21st Strategic Planning Work Session, related **to potential revenue from a commercial parking tax and the process.**
- 7. At last Tuesday's Study Session, Deputy Mayor Woodards requested additional information related to the Community Development Block Grant and the Emergency Shelter Grant funding recommendations, specifically if the organizations recommended had been funded previously and for what amounts. Because historical funding is not considered during the competitive application process for human services, this information was not provided in the presentation. The concern is that previous allocations may affect the decisionmaking process when the criteria for competing for funds does not include that consideration. The exception to this for CDBG and ESG funding occurs during the second year of our application cycle when currently funded programs are recommended for a second year, depending on performance and availability of funding. Therefore, the recommendations are going to look different every other year (no funding history provided in application years, but previous allocations shown in off years). Please see the attached information related to previous allocations.

GRANT APPLICATIONS

- 8. The City applied for the following grants:
 - Freight Mobility Strategic Investment Board Funding for the Port of Tacoma Road Rehabilitation Project, which replaces the existing asphalt pavement with new concrete pavement, constructs sidewalks and curb ramps to provide continuous pedestrian access along the corridor, replaces a temporary street signal with a permanent signal, and provides infrastructure. The City is requesting \$3 million, with a \$500,000 City match required, which is earmarked in the current budget.
 - Coordinated Prevention Grant Offset Cycle Grants funding to assist in: preparing Sustainable Materials Management/Zero Solid Waste Plan; updating the City's construction specifications for greater use of recycled materials; enhancing educational component of the Landfill Tree Nursery; allowing more recycling at the City's transfer station; and, using equipment to expand the Organics to Energy Project. City is <u>requesting \$335,000</u> with an \$83,750 City match required, which is earmarked in the current budget.

After the Council Strategic Planning Work Session on February 21, 2014, Council Member Ibsen sent me an email asking for more information pertaining to a Commercial Parking Tax. The following information is in response to his request.

Per RCW 82.80.030:

- A Commercial Parking Tax can be implemented by the City Council;
- Is a tax on all persons engaged in the commercial parking business;
- The tax is collected by the parking operator and remitted to the City;
- The tax rate can vary with zoning or location of the facility, the duration of parking, the time of the entry or exit, the type or use of the vehicle, or other reasonable factors;
- The rate of the tax may be based either upon gross proceeds or the number of vehicle stalls available for commercial parking use; and
- The proceeds of the commercial parking tax must be used for transportation purposes in accordance with RCW 82.80.070 or for transportation improvements in accordance with chapter 36.73 RCW (Transportation Benefit Districts).

The City of Seattle Municipal Code contains multiple exemptions to the Commercial Parking Tax (see below). For example, reserved parking stalls are exempt because they are considered real property. Taxing these stalls would be considered a form of property tax which is not permitted. Staff at this time was not able to determine what percent of parking stalls are reserved within the City but accounting for these types of stalls would lower the projected tax revenue.

Seattle Municipal Code 5.35.050 - Exemptions

- Parking by a person in a stall reserved exclusively for that person for a period of 30 days or longer.
- Parking of a motor vehicle owned or controlled by a natural person in a stall provided with that person's residence.
- Parking at stadiums and exhibition centers which the City is precluded from taxing pursuant to RCW 36.38.040.
- Parking on City of Seattle streets.
- Parking of vehicles under federal government contracts that are exempt from the retail sales tax.
- Parking charges directly billed to, and paid by, federal, state, or local government.
