1. 14-0595 Tacoma Employees' Retirement System Update and GASB 67/68 Statements.

Tim Allen, Retirement Assistant Director, provided an overview of the retirement system, including defined benefits, funding, contribution rates, investment performance, current plan status, long term challenges, Governmental Accounting Standards Board (GASB) 67 and 68 statements, net pension liability, and pension expense. Discussion ensued regarding investments, GASB reporting effects on market value, actuarial assumptions, administrative expenses, asset organization, and GASB reporting changes.

2. 14-0596 Russell Family Foundation Divestment of Fossil Fuels.

Council Member Mello introduced the next informational briefing on the divestment of fossil fuels process. Richard Woo, Russell Family Foundation Chief Executive Officer, reviewed the relationship between the Russell Family Foundation and the Threshold Group to find an internal and external outlook on fossil fuels. Craig Muska, Director of Investments for Foundation Services with Threshold Group, reviewed fossil fuels, carbon, and energy; Global Industry Classification Standards; and the Energy Action Coalition's Carbon Tracker 200. Discussion ensued regarding the carbon life cycle measurement, investments, bio fuels, new alternatives to fossil fuels, how to lower fossil fuel consumption and carbon output, investing strategies and

risks, divesting in fossil fuels, stranded assets, the impact of divestment on companies, international demand, public policy, "Filthy 15" companies, and investment in big businesses.
