#### Government Performance and Finance Committee

Council Member Lonergan, Chair of the Government Performance and Finance Committee, stated the Committee has met twice since the last report and during that time heard presentations from Jack Kelanic, Information Technology Director, on Emergency Radio Service Access Fees, James Duggan, Fire Chief, on the fire inspection fee implementation, Randy Lewis, Government Relations Officer, on the Fiscal Home Rule, and Jennifer Hines, Assistant Division Manager, Real Property Services and Jeff Capell, Deputy City Attorney, on the Puget Sound Energy franchise renewal. He concluded by stating the next meeting is scheduled on October 7, 2015 and will include an update on the Tacoma Information Management System and the Accela software implementation.

Council Member Campbell stated the Eastside Farmers Market is tomorrow from noon to 4:00 p.m. at Family Investment Park. He then discussed the President of China's visit to Lincoln High School, noting that Nathan Gibbs-Bowling, Lincoln High School, Teacher of the Year, will meet President Xi Jinping. He then discussed possible traffic impacts and road closures.

Council Member Lonergan further reported on the President's visit, stating 21 years ago Xi Jinping signed the sister-city relationship between the City of Fuzhou, China, and the City of Tacoma. He stated, in conjunction with his visit and events happening this week, the sister-city has brought an exhibition showcasing the 21 years of sister-city relationship between the two cities using photographs and cultural artifacts. He stated the free exhibit, entitled Friends, Friendship and Friendship Cities, will be held the next two days at the downtown post office at 1102 A Street.

Deputy Mayor Boe stated the Puget Sound Revels are doing a public sing to celebrate the end of summer and the beginning of autumn on Thursday, October 24, 2015 at 6:30 p.m. at the Chihuly Bridge of Glass.
