REPORTS BY THE CITY MANAGER

City Manager T.C. Broadnax reported the Police Department's Tacoma IF Project was awarded \$69,000 from the COPS Community Policing Development micro-grant program. He stated the Neighborhoods and Community Services Department's Tacoma Gang Reduction Project was awarded \$241,000 from the Office of Juvenile Justice and Delinquency Prevention's fiscal year 2014 Comprehensive Anti-Gang Strategies program.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Council Member Campbell thanked the Mayor for having the President of China come to Lincoln High School. He stated that Wednesday is the Eastside Farmers Market and it will be the last day for the market, Saturday at 9:00 a.m. there will be an event in the McKinley District to depave an area and add plants, and there will be a Project PEACE event on October 5, 2015 at Lincoln High School. Council Member Woodards added that all Tacoma residents are welcome to come and have a conversation with the Tacoma Police Department and City staff about police relations.

Council Member Woodards then stated October is Domestic Awareness Month and on Friday, October 2, 2015, the kickoff to the Courage Campaign will be held at Tollefson Plaza. She stated there will also be programming on CityLine regarding reactions to trauma and working with survivors in the community, housing and employment rights for domestic violence survivors, and support groups throughout the community. She encouraged everyone to be involved.

Infrastructure, Planning, and Sustainability Committee

Council Member Mello, Chair of the Infrastructure, Planning, and Sustainability Committee reported that the Committee has met three times since his last report. He stated on August 12, 2015 the Committee received a presentation on live/work and work/live proposed amendments, and interviewed applicants for the Board of Building Appeals. Council Member Mello stated at the meeting of September 9, 2015, a presentation was heard regarding an interlocal agreement for salmon recovery efforts in the Green River, and at the September 23, 2015 meeting the Committee received presentations relative to community solar, replacement of the Puyallup River Bridge, and a pedestrian crossing improvement project.
