 - Approves the total levy amount to be collected
 Approves the percentage and dollar increase over the prior year's actual levy



General Fund Revenue Variance (Millions)



2016 Levy Restriction

- City Received Property Tax Levy Information from County Assessor
- State Law allows City to increase Property Levy to lower of 1% or the rate of inflation (Implicit Price Deflator)
- For 2016 Levy, Implicit Price Deflator is 0.251%

2016 Levy Restriction

- Regular Property Tax Levy City restricted to 0.251% increase unless the City issues a statement of substantial need
 - \$400 K less than the 1% increase
 - Used as the base for future levies
- With a statement of substantial need, City can increase its regular levy up to 1%
- Statement of Substantial Need:
 - Allows City to maintain its long term financial sustainability and maintain service levels as established in 2015-2016 Adopted Budget
- EMS Property Tax Levy
 - Maintains restriction of \$0.50 per \$1,000 of AV

Regular Property Tax Levy

 Tonight's ordinances authorize the 2016 property tax levy at \$54.9 M, which is a 1% increase over the highest regular levy

Regular Property Tax Levy	\$54.9 M
New Construction Revenues	\$0.9 M
Refund Levy	\$0.3 M
Total Estimated Levy	\$56.1 M
Anticipated Property Tax Revenues (Using historical collection rate)	\$53.4 M

Emergency Medical Services Levy

 This week's ordinances authorizes an increase in the EMS levy to the maximum allowed, given the statutory rate maximum of \$0.5 per \$1,000 of AV

Maximum Levy Allowed in 2016	2015 Assessed Value	Max Levy Rate (per \$1,000 AV)	Statutory Rate Limit (per \$1,000 AV)	Rate Limited Levy
\$10.1 M	\$18.9 B	\$0.55	\$0.50	\$9.4 M
