Ms. Anderson introduced Michael Fowler, World Trade Center Tacoma's Fuzhou Trade Project, and

Louise Tieman, World Trade Center Tacoma. Ms. Tieman discussed the World Trade Center Tacoma, including membership, services, the Minority Business Development Agency grant, trade missions, strategic initiative, regional center, and the 23rd Annual Globe Awards.
