At approximately 12:05 p.m., Tadd Wille, Budget Director, provided an overview of the second quarter 2016 financial report, including an update on the General Fund, General Fund revenues and revenue variance, revenue through June 2015 versus June 2016, General Fund expenditures and expenditure variance; and General Fund supported funds, including the Street Operations and Engineering Fund, Traffic Enforcement Fund, Permit Services Fund, Parking Fund and Public Assembly Facilities. He concluded by providing a budget/finance condition summary.

Discussion ensued regarding revenue streams included in the Traffic Enforcement Fund and increased tax revenues.
