Deputy Mayor Mello further moved to amend Ordinance No. 28374 at Page 6, Line 12, Section 6B.175.070, by adding a new Subsection "P" to read as follows: P. Notwithstanding the requirements in TMC 11.05, food truck vendors licensed under this Chapter shall be exempt from paying the required parking fees and adhering to the designated time limitations while operating at an approved City food truck location during the approved hours of operation.
