Briefing Items

1. <u>16-0838</u> Tacoma Link Expansion Project Update

At approximately 12:08 p.m., Kurtis Kingsolver, Public Works Director, provided opening remarks and introduced Madeleine Greathouse, Sound Transit. Ms. Greathouse provided an update on the Tacoma Link Expansion Project, including a project overview, significant milestones, funding, timeline, final design and recent community outreach. Mr. Kingsolver discussed platform location considerations and Ms. Greathouse concluded by discussing future City Council actions. Discussion ensued throughout regarding center platform configurations, combining contracting opportunities, relocating utilities, the Transit-Oriented Development grant, and collaboration with local organizations relative to station locations and design.

Council Member Lonergan stated the South Sound 911 Policy Board voted to approve the budget for the organization at its last meeting.
