PETITIONER: ST. NICHOLAS GREEK ORTHODOX FILE NO. 124.1370

A. SUMMARY OF REQUEST:

Real Property Services has received a petition to vacate the east eight feet of Yakima Avenue South, lying between South 15th and South 16th Streets, to facilitate and accommodate existing and future building improvements. The area is shown on the attached map, Exhibit 2.

B. GENERAL INFORMATION:

1. Legal Description of Vacation:

The easterly 8 feet of South Yakima Avenue abutting on lots 1 through 12, inclusive, Block 1515 of New Tacoma, according to the plat thereof recorded February 3, 1875, Records of Pierce County, Washington..

2. Notification:

9.22.060 NOTICE OF PUBLIC HEARING The Public Works Department shall cause a 30-day notice to be given of the pendency of the petition by written notice posted in three of the most public places in the City, a like notice in a conspicuous place on the street or alley sought to be vacated, a like notice in a newspaper of general circulation in the City, and a like notice to the legal property owners of all property abutting the right of way requested for vacation as enumerated on the applicant's vacation petition, and to any other interested parties of record. In addition to posting notices of the hearing, the Public Works Department shall mail a copy of the notice to all owners and occupants of the property which lies within 300 feet of the street or alley to be vacated. The said notice shall contain the statement that a petition has been filed to vacate the street or alley described in the notice, together with a statement of the time and place fixed for the hearing of the petition.

In all cases where the proceeding is initiated by the City Council without a petition having been signed by the owners of more than two-thirds of the property abutting upon the part of the street or alley sought to be vacated, notice shall be sent as provided above. Failure to send notice by mail to any such property owner where the current address for such property owner is not a matter of public record shall not invalidate any proceedings in connection with the proposed street vacation.

C. PUBLIC NOTICE:

Real Property Services in conjunction with the City of Tacoma Clerk's office issued the following public notice:

D. PURPOSE OF REQUEST:

The Petitioner plans on acquiring the east eight feet of Yakima Avenue South, lying between South 15th and South 16th Streets, to facilitate and accommodate existing and future building improvements.

E. HISTORY:

The City acquired the Yakima Avenue South right of way in the plat of New Tacoma, according to the plat thereof recorded February 3, 1875, Records of Pierce County, Washington.

F. PHYSICAL LAND CHARACTERISTICS:

Yakima Avenue South is a 100 foot wide improved street right-of-way with planting strips, trees, curb & gutter, and sidewalks on both the east and west side of the right of way. It is mostly level and runs in a north/south direction. The subject area on the eastern side of the right of way includes a ramp and stairs serving St. Nicholas Greek Orthodox church, vegetation, and a bus stop toward the northerly end of the proposed vacate area.

G. APPLICABLE SECTIONS OF THE OFFICIAL CODE OF THE CITY OF TACOMA:

9.22.010 PETITION TO VACATE AUTHORIZED: The owners of an interest in any real estate abutting on any street or alley who may desire to vacate any street or alley, or any part thereof, shall petition to the City Council to make vacation in the manner hereafter provided in this chapter and pursuant to RCW 35.79 or the City Council may itself initiate by Resolution such vacation procedure. The City Council shall require the petitioners to compensate the City in an amount which equals one-half of the appraisal value of the area vacated; provided that if the street or alley has been a public right of way for 25 years or more, the City shall be compensated in an amount equal to the full appraised value of the area vacated; provided that when the vacation is initiated by the City or the City Council deems it to be in the best interest of the City, all or any portion of such compensation may be waived. Except as provided below, one-half of the revenue received hereunder shall be devoted to the acquisition, improvement, and maintenance of public open space land and one-half may be devoted to transportation projects and the management and maintenance of other City owned lands and unimproved rights-of-way.

In the case of vacations of rights-of-way in the tide flats area, defined as easterly of the Thea Foss Waterway (inclusive of the Murray Morgan Bridge), northerly of State Route 509 and westerly of Marine View Drive, the total revenue received hereunder shall be devoted to transportation projects in the tide flats area.

9.22.040 PUBLIC'S RIGHT TO TRAVEL – UTILITIES: Vacation of any portion of a street that is designated as an arterial under Section 11.05.490 of the Municipal Code shall be of a minor nature only and shall not unreasonably limit the public's right to travel upon said street or interfere with the ancillary right to occupy said street for utility purposes.

CRITERIA: Section 9.22.070 of the Official Code of the City of Tacoma. The following criteria have been considered:

- 1. That the vacation will provide a public benefit and/or will be for a public purpose.
- 2. That the right-of-way vacation shall not adversely affect the street pattern or circulation of the immediate area or the community as a whole.
- 3. That the public need shall not be adversely affected.
- 4. That the right-of-way is not contemplated or needed for future public use.
- 5. That no abutting owner becomes landlocked or his access will not be substantially impaired; i.e., there must be an alternative mode of ingress and egress, even if less convenient.
- 6. That vacation of right-of-way shall not be in violation of RCW 35.79.035

Regarding the above Criteria, Real Property Services finds the following:

- 1. The vacation is a public benefit because it returns the property to the tax rolls, cures a known encroachment, and facilitates church improvements.
- 2. City of Tacoma Traffic Engineering has been consulted regarding this petition and <u>does not recommend approval</u> because:
 - a. It will adversely affect the street pattern or circulation of the immediate area or the community as a whole.
 - b. Finds the vacation will adversely affect the public need; and
 - c. The right of way is contemplated and needed for future public use.
- 3. No abutting owner becomes landlocked nor will their access be substantially impaired.
- 4. The vacated area is not close to a body of water as contemplated under RCW 35.79.035.

H. ADDITIONAL INFORMATION:

The area to be vacated has not been assessed for sanitary sewers and is subject to a Connection Charge In-Lieu-of-Assessment per T.M.C. 12.08.350. Should the petitioner wish to clear this item from title, please contact Sue Simpson of the Public Works Department, Real Property Services, at 591-5529 for the assessment amount. Please note that the ordinance establishing the rate of assessment is updated every few years, and the amount quoted may increase in the future. When the petitioner has submitted a development plan, an in lieu of amount will be computed.

I. PROJECT RECOMMENDATIONS:

Proposal is to vacate an 8' wide x 300' long strip of the Yakima Avenue r.o.w. adjacent to the west property line.

BCRA reviewed the following documents:

- Transportation Master Plan
- Downtown Element of the Comprehensive Plan
- Mixed-Use Centers and Downtown Designated Pedestrian/Primary Pedestrian/Core Pedestrian Streets: integrated in the zoning code of TMC 13.06 and 13.06A.
- North Downtown Subarea Plan
- Downtown Tacoma Streetscape Study and Design Concepts

Yakima Avenue is a primary arterial that is designated as a 100' wide Signature Street in Tacoma's Downtown Section of the Comprehensive Plan. This is an older section of the Comp Plan but will be a critical component when taken into consideration in reviewing the vacation of 8' of the street width.










The proposed future street design includes double rows of street trees on each side of the sidewalk with a 6' width of landscaping between the property line and the sidewalk. This vacation request will require a revision to the dimensioning of this element.

The proposed street vacation would require the existing sidewalk to be shifted approximately two feet to the west to the edge of the new 92' right-of-way. New sidewalk and landscape improvements would be required of the applicant between the building and existing curb line. Existing conditions from the curb line would remain in place. Only improvements in the requested 300' vacation area would be required for approval of this vacation.


BCRA recommends that the two planting dimensions along this property edge be reversed with the 8' strip adjacent to the building face. This would enable the sidewalk to be in the new 92' r.o.w. The 8' strip that is being vacated could be planted for 210' of the 300' frontage. Street trees could be planted along the edge where the building doesn't abut. Where the building abuts, the planting strip could be planted with low level vegetation and shrubs.



Conclusion: The 8'x300' vacation of a portion of the 100' right-of-way will not seriously impact the overall effectiveness of the street. The curb-to-curb distance with required drive lanes and bicycle lanes will be maintained. The appearance of the overall width and appearance of two rows of vegetation on each side can be maintained.



The City Engineering Division has reviewed the applicant's application requesting vacation of 8 feet within the Yakima Avenue right-of-way. Yakima Avenue is a 100 foot wide principal arterial.

After consideration the applicants analysis conducted by BCRA Design, we have determined the applicant and representative have not conducted a reasonable analysis of the future street design.

- a. The Transportation Master Plan identifies Yakima Avenue as a primary transit and bicycle route (page 104). The plan further identifies the bicycle route as a protected bicycle facility. In addition, the Transportation Master Plan Project List in Appendix B identifies a project, Yakima Ave (south) for protected bicycle facilities between S 97th St 6th Ave (page 2, Appendix B). Protected bicycle facilities typically require more right-of-way than a standard bicycle lane and includes a barrier between vehicles and bicyclists. Based on NACTO, City of Tacoma Design Manual, Mobility Master Plan Design Guidelines and the Transportation Master Plan, a conceptual design of Yakima Avenue with protected bicycle facilities could be designed within a 98 foot right-of-way. This restricts the width of the protected buffer area and what may be allowed as a barrier and planting strip widths.
- b. The applicants plan did not take into consideration the buffer behind the sidewalk, minimum arterial sidewalk widths, minimum bicycle lane, minimum protected bicycle buffer, and left turn lanes.
- c. Yakima Avenue is a key corridor for alternative modes of travel. This corridor connects the south end of Tacoma at S 96th Street through downtown and to the north end of Tacoma at 6th Avenue.



Based on the review of the applicants analysis and the City's policies and plans for future network priorities, Public Works Engineering Division does not support the request to vacate 8 feet of Yakima Avenue. A smaller request of 2 feet may be allowed, provided that the sidewalk and bus stop remain in public right-of-way or are relocated.

Bill,

Traffic's main concern is to ensure that there is adequate right-of-way (ROW) for the desired buildout of Yakima Ave. A street vacation can adversely impact how a ROW is used. Below are design guidelines and standards to help provide a cross-section or design that demonstrates the buildout of Yakima and the requested vacation.

- 1) Pierce Transit Bus Stop Manual You'll want to refer to this manual for new bus stop pad replacement for benches or shelters. It appears that the design standards are on S1.10 and S1.20. As part of the relocation, Pierce Transit may want to see a shelter be installed. I've include Tina Vaslet from Pierce Transit on this email. http://www.piercetransit.org/file_viewer.php?id=1542.
- 2) Roadway design As I mentioned below, Yakima Ave is a designated transit and bicycle route (protected bike facility, page 2 of 16 in the Appendix of the Transportation Master Plan). NACTO Urban Bikeway Design Guide provides widths/design of various protected bike facilities. The City of Tacoma Design Manual outlines the minimum sidewalk and lane widths in Chapter 4.

The City Engineering Division has reviewed the applicant's application requesting vacation of 8 feet within the Yakima Avenue right-of-way. Yakima Avenue is a 100 foot wide principal arterial.

After consideration the applicants analysis conducted by BCRA Design, we have determined the applicant and representative have not conducted a reasonable analysis of the future street design.

- a. The Transportation Master Plan identifies Yakima Avenue as a primary transit and bicycle route (page 104). The plan further identifies the bicycle route as a protected bicycle facility. In addition, the Transportation Master Plan Project List in Appendix B identifies a project, Yakima Ave (south) for protected bicycle facilities between S 97th St 6th Ave (page 2, Appendix B). Protected bicycle facilities typically require more right-of-way than a standard bicycle lane and includes a barrier between vehicles and bicyclists. Based on NACTO, City of Tacoma Design Manual, Mobility Master Plan Design Guidelines and the Transportation Master Plan, a conceptual design of Yakima Avenue with protected bicycle facilities could be designed within a 98 foot right-of-way. This restricts the width of the protected buffer area and what may be allowed as a barrier and planting strip widths.
- b. The applicants plan did not take into consideration the buffer behind the sidewalk, minimum arterial sidewalk widths, minimum bicycle lane, minimum protected bicycle buffer, and left turn lanes.
- c. Yakima Avenue is a key corridor for alternative modes of travel. This corridor connects the south end of Tacoma at S 96th Street through downtown and to the north end of Tacoma at 6th Avenue.






Based on the review of the applicants analysis and the City's policies and plans for future network priorities, Public Works Engineering Division does not support the request to vacate 8 feet of Yakima Avenue. A smaller request of 2 feet may be allowed, provided that the sidewalk and bus stop remain in public right-of-way or are relocated.



At the hearing on October 20, 2016, the Hearing Examiner left the record open for three weeks to allow the Petitioner to discuss street vacation petition number SV 124.1370 with City of Tacoma Traffic Engineering ("Traffic"). At the hearing, Traffic did not support the petitioner's request to vacate an eight foot wide area on the easterly side of the Yakima Avenue South right of way, between South 15th and South 16th Streets.

Since then, the Petitioner has discussed the vacation petition with Traffic and the parties have come to an agreement. Please see the attached memo dated November 14, 2016 from Traffic Engineering. Real Property concurs with Traffic's position and also supports the vacation petition on behalf of the City.




The City Engineering Division has reviewed the applicant's revised application requesting vacation of 6 feet within the Yakima Avenue right-of-way for approximately 150 ft in length.

After consideration the applicants analysis conducted by BCRA Design, we have determined the applicant and representative have conducted a reasonable analysis of the future street design, which includes the Transportation Master Plan identifies Yakima Avenue as a primary transit and bicycle route (page 104).

BCRA provided an updated site plan, consistent with NACTO and the City's Design Manual, that demonstrates a protected bicycle facility and transit stops can be accommodated within the proposed street vacation. The actual street design will not be determined until funding for preliminary engineering or construction is obtained; however, the street vacation appears to accommodate the intent of the Transportation Master Plan vision.




