The City proposes to decrease the \$750,000 allocation initially proposed for the Family Justice Center. For this biennium, a portion of the funds previously allocated for the FJC will be allocated to the YWCA Pierce County and the Korean Women's Association.

The long term plan is for DV services not to compete for funding in order to highlight the high need for domestic violence service provision

A question was raised around whether the HSC would be able to see outcomes from organizations not participating in the competitive process, and Pam assured those outcomes will be shared.

Al made a motion to support the city's plan of reallocating a portion of the funding administered to the FJC to the YWCA and KWA in order to close gaps, Jason seconded.
