FIRST READING OF ORDINANCES

20. ORD28408

An ordinance amending Chapter 12.13 of the Municipal Code, relating to Click! Network Cable TV Products, to adjust the rates by an average of 13 percent in 2017 and offer promotional pricing.

REPORTS BY THE CITY MANAGER

City Manager T.C. Broadnax stated as part of voter approved street initiatives, the City Council made a commitment to use a portion of the money as grant match to secure funds for critical infrastructure projects with a goal of securing at least \$10 million annually. He reported in 2016, Public Works was successful in leveraging \$4.2 million of City funds to obtain \$19.9 million in grants to further the design and construction of 11 critical infrastructure projects, including: Port of Tacoma Road, Taylor Way, South 56th Street, Pipeline Trail, Lister Elementary Safe Routes to Schools, First Creek Safe Routes to Schools, Fawcett Avenue, South Stevens/Tyler/ 66th Street Bike and Pedestrian Connector, Portland Avenue Corridor Signal Upgrades, South Tacoma Way Corridor Safety Improvements, and Lincoln District Streetscape/Yakima Festival Street.

He then reported on the Department of Ecology's (Ecology) review of the environmental impact statement relative to the liquefied natural gas plant, stating Ecology has the authority to require the City to conduct additional environmental review if Ecology finds it to be necessary, even a supplemental environmental impact statement (SEIS), and Ecology has not done so. He stated the City has pointedly asked if a SEIS is required on the Puget Sound Energy project, and the answer has been consistently no. He also noted this document, as well as a frequently asked questions document, is being posted on the website.
