3. <u>17-0138</u> Modifications to TMC to incorporate FEMA flood insurance rate map changes [Sue Coffman, Building Official, PDS]

At approximately 4:36 p.m., Sue Coffman, Planning and Development Services, discussed proposed modifications to the Tacoma Municipal Code to incorporate Federal Emergency Management Agency (FEMA) flood insurance rate map changes, including regulation changes, flood maps, base flood elevation, Tacoma's flood regulations, types of flood zones, map changes from 2007 to 2017, proposed changes, community outreach, and schedule.

Discussion ensued regarding base flood elevation changes, new flood maps versus current, insurance rates and increases, and outreach.

Ms. Coffman briefly summarized the presentation and discussion continued regarding finished floor elevations, the outreach process, holding community meetings, public education, and properties undergoing construction within FEMA flood zones.
