

2016 Unexpended Funds



- Residential Maintenance \$ 3.1 M
 - Contract out more packages in 2017-2018 to catch up
 - Some reserve to partner with utilities and agencies in ROW
 - LID backlog
- Capital Arterial Freight \$ 0.6 M
 - Balance will be spent down in 17/18 as projects go into construction
- Capital Active Transportation \$ 0.9 M
 - Staff will work with Transportation Commission to fund more active transportation programmatic projects (ADA, bike/ped, sidewalks, and partnerships)
