At approximately 4:31 p.m., Martha Anderson, Community and Economic Development, provided an overview of 2017-2018 Annual Action Plan funding recommendations, including annual Federal funds, 2015-2019 Consolidated Plan, Committee and City Council approval, Housing and Urban Development (HUD) community planning and development allocation, 2017-2018 Community Development Block Grant (CDBG) funds, Tacoma Community Redevelopment Authority (TCRA) approval process, recommended community development and neighborhood revitalization activities, recommended housing funding, Single Family Rehabilitation Loan and Grant photos, recommended TCRA housing activities, multi-family development photos, recommended economic development funding, reprogrammed funds summary, and 2017-2018 HOME Investment Partnerships Program funds.

Nhan Nguyen, Neighborhood and Community Services, provided an overview of Human Services funding recommendations, including CDBG public services and Emergency Solutions Grant funding priorities, allocation process, and 2017-2018 recommended allocations. Ms. Anderson concluded by discussing next steps.
