AMENDMENT NO. 6 TO PROFESSIONAL SERVICES CONTRACT

THIS AMENDMENT is made and entered into effective as of the ____ day of ______ 2017 ("Effective Date"), by and between the **CITY OF TACOMA**, Tacoma Fire Department (hereinafter called the "CITY") and **WENDT CONSULTING AND GIS SERVICES** (hereinafter called the "CONTRACTOR").

WHEREAS, the CITY and the CONTRACTOR entered into a Professional Services Contract (the "Contract") for professional information technology consulting and geobase information related services in the amount of \$45,000 on January 24, 2011; and

WHEREAS, the CITY and the CONTRACTOR subsequently agreed through five previous amendments to the Contract to increase the contract by \$126,660 to a new total of \$171,660 and extend the contract through December 31, 2016, for additional work; and

WHEREAS, the Tacoma Fire Department desires to retain the consultant updating the City's streets files to support the Fire Department's Computer Aided Dispatch System, to perform additional work enhancing the Fire Department's online mapping capability, and to support the Department's Community Risk Profile. The Parties desire to further amend the Contract to increase the total price thereof by the sum of \$40,000 and extend the term of the contract for one additional year.

NOW, **THEREFORE**, the parties hereby agree as follows:

- 1. Section 2. A. of the Contract is amended as follows:
 - A. All services shall be satisfactorily completed on or before December 31, 2017, and this Contract shall expire on said date unless mutually extended in writing by the Parties.
- 2. Section 3. B. of the Contract is amended and replaced as follows:
 - A. The total price to be paid by the CITY for the CONTRACTOR'S full and complete performance of the Scope of Work hereunder shall not exceed \$211,660 without the written consent of the CITY. Said price shall be the total compensation for CONTRACTOR'S performance hereunder including but not limited to all work, deliverables, materials, supplies, equipment, subcontractor's fees, and all reimbursable travel and miscellaneous or incidental expenses to be incurred by CONTRACTOR.

EXCEPT AS EXPRESSLY MODIFIED HEREBY, ALL OTHER TERMS AND CONDITIONS OF THE CONTRACT SHALL REMAIN THE SAME AND IN FULL FORCE AND EFFECT.
