STUDY SESSION/WORK SESSION

4. The City Council Study Session of Tuesday, April 11, 2017, will be held in Room 16 of the Tacoma Municipal Building North, at Noon. Discussion items will include: (1) Opioid Epidemic; (2) Other Items of Interest — Council Consideration Request — Funding for Implementation of an Anchor Institutions Initiative; (3) Committee Reports; and, (4) Agenda Review and City Manager's Weekly Report.

At Tuesday's Study Session, the Director of Health for Tacoma-Pierce County Health Department, Anthony Chen, MD, MPH, will provide a presentation on the opioid epidemic, which will include statistics, effects of opioid misuse, and how we use the Washington State Interagency Opioid Working Plan in our community response.

Under Other Items of Interest at Tuesday's Study Session, Council Member Ibsen will be sharing a Council Consideration Request (CCR attached) for the use of up to \$50,000 of City Council contingency funds for a third party consultant to assist staff with the development of a targeted Anchor Institutions strategy. As background, Council Member Ibsen shared a CCR for staff to formalize an Anchor Institutions strategy at the December 7th Study Session. The stated focus areas include workforce development, procurement, community wealth building, and increased livability. Staff indicated that the next step in developing the strategy is to partner with a consultant experienced in anchor-related planning and outreach; therefore, this follow-up CCR is requesting the use of the Council Contingency Fund for that purpose.

Matt Balk - VOS Excellence in Operations Award winner Operations Manager Tacoma Venues & Events at the City of Tacoma, WA

Matt joined Tacoma Venues & Events (formerly Public Assembly Facilities) just over 3 years ago. He arrived to an operations team decimated by recent layoffs, a city budget \$60m in the red, and a clear mandate for change. Matt did not shy away from the challenge.

Matt worked creatively with the local utility and leveraged very limited funds to complete several key capital projects, including the installation of energy and cost-saving LED lighting in the Convention Center Exhibition Hall, wireless lighting controls and improvements in sound and rigging. He has nurtured a 33-year-old stadium and successfully secured funding for over \$21 million in key improvements for the Tacoma Dome. In spite of its age and considerable deferred maintenance issues at the Dome, through the diligence of Matt and his operations team, customer and client satisfaction remains high. Simple, cost-effective aesthetic changes (all completed with in-house labor) allowed Matt and team to transform the back of house entrance and hallway area and ensure a more positive experience for production staff, artists, coaches and athletes. Matt facilitated the installation of a massive DAS/WIFI infrastructure upgrade in both the Dome and the Convention

Center and coordinated the selection, installation, and operations of walk-through metal detectors at all Dome entrances. At the 13-year-old Convention Center, clients constantly marvel at the pristine condition of the venue and the exceptional service provided by maintenance workers and custodians.

If the definition of a true leader is someone who offers hope and vision, Matt fits the bill. His consistent approach, passion for fairness and excellence and zero tolerance for complacency has created nothing short of a 180-degree shift in the operations department. In his first year, the number of grievances filed plummeted by 95%, and since then he has been able to deliver terms favorable to both the labor unit and the city in several rounds of contract negotiations. Matt revitalized the safety committee and directed resources to address safety issues in a timely fashion. Matt infused new energy into his workforce. He patiently and thoughtfully placed staff in areas where they could be most successful. Through clear communication and respect for his experienced team, now joined by carefully selected new team members, Matt initiated an obvious positive culture shift in a relatively short period of time. Everyone is happier to come to work and contribute to the ongoing improvements and review of existing processes.

Jan Szabat - VOS Excellence in Engineering Award winner Director of Engineering Services Shaw Conference Centre (Edmonton, Alberta Canada)

For the past 30 years, Jan Szabat has played an instrumental role in overseeing the maintenance of one of Edmonton's most iconic assets. Leading the engineering operations for a 33-year-old facility is not easy, but through Jan's leadership the Shaw Conference Centre has maintained its position as a premier meetings and events destination in Canada.

Throughout the last year, Jan has overseen numerous major projects in the facility. These include flood mitigation and major bathroom renovations to the \$12.5-million replacement and modernization of six escalators. Moreover, he has overseen the development of sustainable permaculture on the grounds, including the creation of an Indigenous Medicine Wheel Garden on the rooftop of our Riverview Room.

And that's not all. With the entire atrium roof of the 150,000-square-foot facility covered in glass, Jan has also developed plans to phase in the replacement of the glass next year, a multi-million-dollar project that could have a major impact on operations. He also has had his plans approved to replace all the carpet on our stairs, and will oversee the modernization of the large canopy outside the main entrance to our facility. This is all in addition to his day-to-day responsibilities of making sure the building is running efficiently so we can best serve our guests.

Jan's commitment to sustainability has played a major role in allowing the Shaw Conference Centre to receive BOMA Best certification, and be the first conference venue in Canada to receive Green Key

Level 5 certification. He has also helped lead efforts for the facility to become APEX/ASTM certified, which we are currently being evaluated for.

The above is only a small snapshot of what Jan has done over the past year. His dedication and leadership over the past 30 years at Edmonton's convention centre is unapparelled within our industry. I strongly believe he deserves this industry recognition.



ITEM/ISSUE PROPOSED FOR COUNCIL CONSIDERATION:

The following item will be scheduled on the agenda of the earliest available Study Session:

I respectfully ask for City Council concurrence to allocate \$50,000 from the Council Contingency Fund for hiring a third party consultant to help staff develop a targeted anchor institutions strategy.

BRIEF BACKGROUND:

Anchor institutions are non-profit institutions with a large economic footprint that, once established, tend not to move location. Anchors have major impact in their cities due to their roles as employers, purchasers of goods and services, and as real estate, business, and human capital developers. Many communities increasingly rely on anchor institutions as engines to stimulate local economies and enhance their competitiveness. Our anchor institutions include: University of Washington Tacoma, University of Puget Sound, Tacoma Community College, Bates Technical College, Tacoma Public Schools, CHI Franciscan, Tacoma Housing Authority, Multicare, and the City of Tacoma, as well as other partners such as Greater Tacoma Community Foundation.

A formalized anchor institution program is fully supportive of Tacoma 2025 metrics. These include its goal areas of Livability, Economy and Workforce, Civic Engagement, and Education and Equity and Accessibility. Furthermore, the City of Tacoma's involvement in the national Anchor Institutions Task Force will allow us to continue to learn alongside other cities hoping to make similar progress.

At the December 7, 2016 Study Session, the City Council discussed a CCR which directed staff to begin the implementation of an anchor institutions strategy. The stated focus areas included workforce development, procurement, community wealth building, and increased livability. Staff indicated that the next step in developing the strategy is to partner with a consultant experienced in anchor-related planning and outreach.

FUNDING/ACTION REQUEST:

I request that the City Council allocate up to \$50,000 from the Council Contingency Fund to hire a third party consultant to assist staff with the Anchor Institutions Initiative. The focus of this Initiative will be to complete a comprehensive study to align current planning efforts, identify gaps, and achieve Tacoma 2025-related goals. Furthermore, I request that the Interim City Manager negotiate a professional services agreement that outlines the strategy's scope of work and deliverables.

SUBJECT: DATE: McCarver Street Rail Crossing April 4, 2017

ISSUE:

The Public Works Department is responding to a request for information that arose during Citizens' Forum at the March 22, 2017, City Council meeting. A citizen requested an update on the letter that was sent to BNSF regarding the McCarver Street rail crossing.

BACKGROUND:

On January 27, 2017, the Public Works Department upgraded the traffic and pedestrian control signage for the McCarver Street crossing. This included special and customized warning and regulatory signing determined to be appropriate for the crossing conditions.

On February 27, 2017, Public Works submitted a letter (copy attached) to BNSF describing the City of Tacoma's intentions for additional traffic and pedestrian controls for the McCarver Street rail crossing. The letter recommended the following that will require some level of review, approval, and/or implementation by BNSF:

- Fencina
- Sidewalk Modifications
- Pedestrian Gate Arms
- Investigate Installing an Another Train Warning System
- Street Lighting
- Upgrade Existing Flashing Warning Lights

UPDATE:

Public Works and BNSF staff have had several interactions regarding the installation of traffic controls recommended for the McCarver Street rail crossing:

- March 9, 2017: Conference call with BNSF outlining specific pedestrian and traffic controls to be implemented by Public Works and requesting what process/permitting would be necessary to obtain BNSF approval and implementation.
- March 23, 2017; Follow-up conference call with BNSF for mutual update of coordination efforts.
- March 24, 2017: Public Works installed supplemental graphical-based signs indicating a two-track crossing for pedestrians.
- March 31, 2017: BNSF submitted for review the cost estimate for pedestrian gates and is evaluating a "second train approaching" advanced warning sign.
- April 3, 2017: Public Works responded to BNSF with regard to their estimate with some additional questions and asked if fencing improvements could be approved and installed prior to the 4th of July.
- Public Works is working to schedule a site survey with the BNSF Roadmaster of existing rail and roadway infrastructure for the development of project plans.

- BNSF will continue to work internally for coordination primarily on the preliminary engineering, cost estimate, and/or feasibility for the pedestrian gate arms and an Another Train Warning System.
- Public Works is still working with BNSF to better understand and define their potential schedule for installation of traffic controls.

Dear Mr. Wagner:

The Public Works Department has reviewed the traffic controls at the McCarver Street crossing (#085730J). We appreciate your continued coordination and feedback regarding vehicular and pedestrian controls at this crossing. The City's recommended controls for this specific crossing are described below, but please note there are several other track crossing environments within the City such as 6th Avenue at Titlow Beach (#085742D) that will be undergoing similar crossing assessments, which will require your continued coordination in the near future. The City understands most of these controls will require some level of review, approval, and/or implementation by BNSF.

- Fencing: this work is envisioned to be carried out by City forces or City-contracted
 forces and may require a work easement and/or permanent easement from BNSF. A
 fencing plan will be developed by the City that best directs pedestrians to the appropriate
 crossing location (without impeding BNSF access needs).
- Sidewalk: the addition of new sidewalk and modification/removal of existing sidewalk
 will be carried out by City forces or City-contracted forces and may require a BNSF
 easement to conduct the work and/or BNSF notification prior to carrying out the work.
 The sidewalk changes, which will also include removal of the unnecessary asphalt
 paving within the northeast quadrant of the crossing, will be complementary to the
 fencing plan.
- Pedestrian Gate Arms: this control will provide a visible and physical barrier. We
 understand that this control will be assessed, designed, procured, and implemented by
 BNSF as part of an anticipated formal agreement and Notice to Proceed process.
- Another Train Warning System: the City requests that BNSF investigate track
 signaling and circuitry infrastructure requirements, and the related design, procurement,
 and implementation costs, to incorporate Another Train Warning System (ATWS), similar
 to what is currently in use on the Metra/Union Pacific West Line in the Chicago area.
 Depending on the cost estimate developed by BNSF, the City may choose to initiate an
 additional agreement to design and implement the system.
- Lighting: this work is envisioned to be carried out by City forces or City-contracted forces and may require a work easement and/or permanent easement from BNSF.

Replaced Flashing Lights: the City understands that the existing flashing lights at the
crossing, either on the vehicle gate arms and/or the railroad signal poles, can be
replaced with newer LED technology that will be more visible in daytime and nighttime
conditions. If this is confirmed and the cost to procure/implement is commensurate with
the benefit, the City requests this control.

For the crossing controls listed above that require BNSF involvement, the City would like to enter into a formal agreement with BNSF to proceed with the necessary actions related to design, cost determination, and implementation. We understand that this process will entail one or more of the following: 1) formal safety assessment on-site with other agency stakeholders, 2) BNSF-led survey and assessment of rail-related infrastructure, 3) preliminary and final cost estimate preparation for materials, labor, and installation of applicable elements, 4) procurement of equipment and materials, and 5) scheduling of track operations to facilitate implementation of control elements.

The City is committed to making and/or funding these improvements, and is interested in expediting the approval process. To that end, please let us know how we can work together to get these controls constructed as soon as possible and please continue to work with Brennan Kidd in our Engineering Division for any additional information or action needed from the City.
