## WHERE DID WE START?

- Formed in 1988 with petitions from downtown property owners.
- City Council passed Ordinance 24058 establishing the BIA for a 10-year term
- Renewed in 1998 (Ord 26205) & 2008 (Ord 27696)
- Consistently managed by the Local Development Council of Tacoma (dba Downtown Tacoma BIA)
- Management agreement between the LDC/BIA & Tacoma-Pierce County Chamber
- Annual budget and work plan approval process:

January: Board approves draft & sends to all ratepayers/property owners

February: Annual ratepayer meeting passes/amends

March: City Council approves April: Invoices sent out by City

May: New BIA fiscal year begins (May-April)

## **BIA SURVEY: DOWNTOWN OR BIA**

- "Downtown Tacoma extends beyond the BIA area. Outside your sphere of influence safety, litter and graffiti are still issues."
- "Expand to Tacoma Avenue and to the Waterfront."
- "Graffiti, it's everywhere!! Particularly bad lately in Stadium District."
- "I'd say security doesn't extend far enough west to support the upper areas of downtown."
- "Expand boundaries up Tacoma Avenue and north to Stadium District. Tacoma Avenue is an eyesore similar to downtown before the BIA."
- "I feel like the heart of downtown is definitely safe and clean, but the perimeter isn't large enough to answer strongly agree. If you go just 2-3 blocks in some areas of downtown it can be pretty sketchy."
