3. <u>17-0304</u> Six Year Comprehensive Transportation Improvement Project [Diane Sheesley, Project Manager, Public Works]

At approximately 4:34 p.m., Diane Sheesley, Public Works (PW), provided an update on the Six Year Comprehensive Transportation Improvement Project (TIP), including background information, issues, changes to the TIP layout,

projects to be added, funding for added projects, funding for the proposed draft TIP, and next steps.

Discussion ensued throughout regarding Local Improvement Districts, unidentified funding, number of total projects on the TIP, and prioritization.

> Discussion ensued regarding timeline, the Lincoln Neighborhood Revitalization Project, potential grant funding after proposed ordinance is passed, Complete Streets guidelines, feedback received, partnering with the development community, design standards, exempt projects, and bringing the proposed ordinance back to discuss further at the April 12, 2017 meeting.

#### 5. <u>17-0307</u> Comprehensive Building Maintenance Code Review [Dan McConaughy, Code Compliance, Neighborhood and Community Services]

At approximately 5:33 p.m., Lisa Wojtanowitz, Neighborhood and Community Services (NCS), provided background information relative to the Comprehensive Property Maintenance Code review, and introduced Dan McConaughy and Allyson Griffith, NCS. Mr. McConaughy provided an overview of the scope of the code review, and Ms. Griffith reviewed outreach and the timeline.

Discussion ensued throughout regarding available languages of forms used to report nuisances, access to services, rental properties, outreach, and creative solutions to blighted properties.
