14	WHEREAS Brentwood Real Estate, LLC, is proposing to develop 45 new			
15	market-rate and affordable housing units to consist of 45 one-bedroom, one-bath			
16	units, ranging in size from 420-460 square feet and renting for \$650-\$750 per			
17 18	month, as well as 31 on-site residential parking stalls, and			
19	WHEREAS the Director of Community and Economic Development has			
20	reviewed the proposed property tax exemption and recommends that a conditional

22	property tax exemption be awarded for the property located at 2515 South 48th
