**Dear Mayor and Council Members:**

**ACTION REQUESTED**

1. As a reminder, the **City Manager finalist interviews** will be conducted on Thursday, May 11<sup>th</sup> and Friday May 12<sup>th</sup>, with a Special Meeting of the City Council on Saturday, May 13<sup>th</sup>. The agendas for these meetings will be provided next week. The tentative schedule is as follows:

**Saturday, May 13<sup>th</sup>:**

- 10:00 a.m., Special Meeting of the City Council. The purpose of the meeting will be to have an Executive Session to discuss the qualifications of the City Manager candidates. In addition, there will be a resolution for your consideration after the Executive Session to appoint one of the candidates.

**ITEMS OF INTEREST**

2. As reported to you previously in the March 30<sup>th</sup> Weekly Report, Office of Equity and Human Rights has organized an Immigrant and Refugee planning group that has met twice to develop the **convening of immigrants and refugees** as directed by Resolution No. 39642. At the March 15<sup>th</sup> meeting, the planning team decided to reach out to their respective communities to ascertain the location, timing, and resources that would best meet the needs of the varying segments of their communities. A third meeting was initially set for April 24<sup>th</sup>; however, the planning team members requested more time to fully engage with a wider cross-section of their respective communities and the meeting was postponed until May 10<sup>th</sup>. After this meeting, staff expects to have a better picture of the form of the immigrant and refugee convening, to have planning groups which will approach event logistics, outreach, and design of the desired task force, and to provide to Council a summary of the identified needs brought forward from the community.

3. At the **Community Partners Retreat** on April 14, 2017, representatives from the Community and Economic Development Department, Economic Development Board, Travel Tacoma, Port of Tacoma, Chamber of Commerce, Tacoma Public Utilities, Workforce Central, and Pierce County Office of Economic Development met to identify key actions to address problems and challenges in economic development. The proposed strategies and actions identified will assist in our continuing efforts to meet the community vision set out in Tacoma 2025, which envisions a growing economy where Tacoma Residents can find livable wage jobs in key industry areas and that Tacoma will be a place of choice for employers, professionals and new graduates.

The actions proposed by the community partners at the Economic Development Retreat include:

- **Develop methods of highlighting the potential for office development.**
  - Supportive of Tacoma 2025 Goal: Increase the number of diverse livable wage jobs and decrease the number of vacant properties downtown and in the neighborhood business districts.
- **Partner agencies establish a recurring meeting schedule to assist in on-going management of collaborative initiatives.**
  - Supporting of Tacoma 2025 Goal: Improve government performance and collaboration
- **Creating uniqueness for Tacoma/Pierce County and promotional capacity.**
  - Supporting of Tacoma 2025 Goal: Increase positive public perception related to the Tacoma economy and increase the percent of people relocating to the city and affordability of housing compared to neighboring jurisdictions.
- **Continue efforts developing a prepared workforce.**
  - Supporting of Tacoma 2025 Goal: Increase the availability of industry specific education programs to support identified growth sector and increase the number of Tacoma households that have livable wage jobs within proximity to the city.

Thank you to our Community and Economic Development Department and our Economic Development Partners.

4. The Office of Environmental Policy and Sustainability would like to announce an update to **the 2016 Environmental Action Plan (EAP) Progress Report**. Based on additional information from the Environmental Services Department's Surface Water Utility progress rating for the following items in the Climate Resiliency Category which have increased.



- C6 – Ensure that near-term capital projects consider climate change risks. –The progress rating was 1 and has been increased to 2 due to recommended changes to the City's design storms to manage changes in rainfall patterns. Current City stormwater conveyance capital projects are evaluated using more intense rainfall events than currently required by the City's design manual. Pipes sizes have been increased to accommodate flows from more intense storms.
- C8 – Inspect, maintain, and upgrade critical infrastructure. - The progress rating was 1 and has been increased to 3 due to on-going inspection programs for many of city's surface water assets. In addition, our Wastewater Utility completed construction of the flood wall around the Central Treatment Plant, protecting the facility from increased frequency of flooding and sea level rise.
- C10 – Evaluate the development code related to landslide and flooding hazards – The progress rating has been revised from 1 to a 2. The revised rating was determined to be appropriate because the city hired a consultant and received recommendations on changes to the City's design storms to manage changing rainfall patterns. Appropriate changes to the City's Stormwater Management Manual are being evaluated.

#### **STUDY SESSION/WORK SESSION**

7. The **Joint City Council/Public Utility Board Study Session** of Tuesday, May 9, 2017, will be held in Room 16 of the Tacoma Municipal Building North, at Noon. Discussion items will include: (1) **Tacoma Power's Solar Power Program and Incentives Update**; and, (2) **Executive Session – Pending and Potential Litigation**. Immediately following the Joint Study Session, there will be a regular City Council Study Session. Discussion items include: 1) **Budget Amendment Request for the Proposed Tideflats Subarea Plan**; 2) **Other Items of Interest-Council Consideration Request for Marijuana Regulations Review**; (3) **Committee Reports**; and, (4) **Agenda Review and City Manager's Weekly Report**.

At the request of Mayor Strickland, during next Tuesday's Joint City Council/Public Utility Board Study Session, **Tacoma Power will present on the use and incentives relating to the Solar Power Program, program options and legal limitations.** As a second item on the Joint Study Session, there will be an **Executive Session to discuss pending and potential litigation.**

Immediately following the Joint Study Session there will be a regular City Council Study Session. As the first topic, Council Member Lonergan will share a request for a **2017-2018 Biennial Budget amendment to add General Fund dollars to support external contracting services not to exceed \$500,000 for a Tideflats Subarea Plan.** This funding need is related to Resolution No. 39723, which requests the Interim City Manager identify resources necessary to move forward in a timely manner on the Tideflats Subarea Plan and initiate discussion about an Interlocal Agreement between the City and Port, which would include funding from both organizations and approval by both legislative bodies.

Under Other Items of Interest at the Study Session, Deputy Mayor Thoms will share the attached **Council Consideration Request related to the City's marijuana regulations review.** The request is **to include Metropolitan Park District parks, recreation centers, facilities, and playgrounds in the 1,000 foot buffer zone for marijuana uses.**

9. Under Final Reading of **Ordinance No. 28427** on Tuesday's City Council agenda, a **Substitute Exhibit A and B have been prepared for your consideration.** Amendments on the proposed substitute revenue and expenditure exhibits are as follows:
  - Revenues - Adjusting Fund 1050 Transportation Revenues to receive \$750,000 in funding from Washington State Department of Transportation for East 25<sup>th</sup> Street Improvements. Funding will then be transferred to the capital budget.
  - Expenditures - Adding General Fund dollars to support external contracting services not to exceed \$500,000 for a Tideflats Subarea Plan. (As previously mentioned under Council Member Lonergan's Study Session topic)

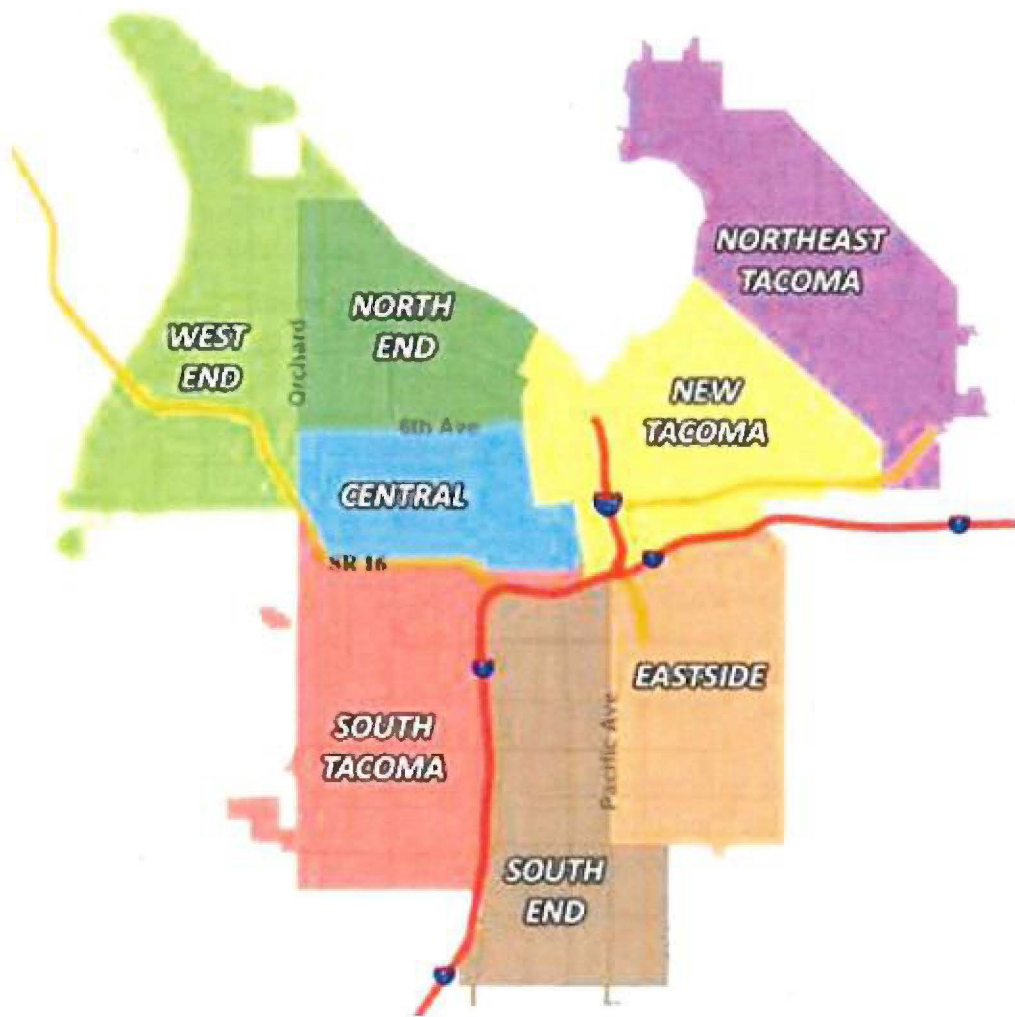

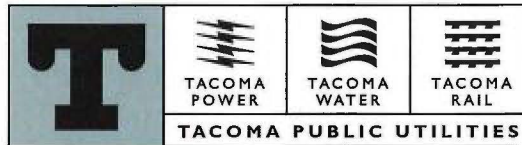

**ITEM/ISSUE PROPOSED FOR COUNCIL CONSIDERATION:**

**I ask for your support for the inclusion of the following item on the agenda at the earliest available meeting of the Study Session:**

I respectfully ask the City Council to amend the City of Tacoma's marijuana regulation ordinance to include Metropolitan Park District parks, recreation centers, facilities, and playgrounds in the 1,000 foot buffer zone for marijuana uses.

**BRIEF BACKGROUND:**

It is clear from the relevant statutes and regulations (RCW 69.50.331(8) (a) and (b) and WAC 314-55-050(10)-(11)) that the State Legislature and the Washington State Liquor and Cannabis Board intended public playgrounds to be in a class of uses having the highest level buffer from marijuana uses. The buffer for parks, recreation centers, and facilities can be reduced, but the City's ordinance is presently unclear about any such reduction. The gap for playgrounds arises from the State's failure to include playgrounds (and recreation centers and facilities) owned by a metropolitan parks district in its definitions.
