## REPORTS BY THE CITY MANAGER

Elizabeth Pauli, Interim City Manager, stated Planning and Development Services launched a Residential Infill Pilot Program in the fall of 2016 to promote innovative resident infill development types and housing choices, while ensuring such development demonstrates high quality building and site design. She reported on Thursday, April 27, 2017, an advisory committee of staff and citizens will meet to recommend projects submitted through the pilot program to move forward to the permitting process, in Conference Room 16 of the Tacoma Municipal Building North, located at 733 Market Street, at 1 p.m. Interim City Manager Pauli concluded by reporting Community and Economic Development is offering a free commercial leasing workshop on Wednesday, May 3, 2017, at Bates Technical College, Business Center Auditorium, located at 1101 Yakima Avenue, at 6:00 p.m.

Government Performance and Finance Committee

Council Member Lonergan, Chair of the Government Performance and Finance Committee, stated at the April 5, 2017 meeting the Committee recommended a wireless telecom franchise agreement with Mobilitie, were briefed on the 2016 Open Data Report, and recommended to Council a memorandum of understanding with South Sound 911 related to radio system access fees. He stated on April 19, 2017, a discussion was held about the deliberative process and the council consideration request process. He concluded by stating the meeting scheduled for May 3, 2017 is cancelled and the next meeting will be held on May 17, 2017 and will include a discussion around permit fees and cost recovery and a presentation on the 2016 End of Year Report.
