SUBJECT: Resolution Partnering with the State Department of Transportation to Install a Historic

Interpretive Display at the New Amtrak Station at Freighthouse Square

DATE: May 23, 2017

SUMMARY:

Authorizing appropriate City officials to enter into a State Participation Agreement (SPA) with the Washington State Department of Transportation (WSDOT) to install a large scale, tile Historic Interpretive Display this fall inside the New Amtrak Station, but visible from the street.

STRATEGIC POLICY PRIORITY:

Cultivate a vibrant cultural sector that fosters a creative, cohesive community.

BACKGROUND:

The new Amtrak Station at Freighthouse Square is scheduled for completion this fall. Over the last four years the community, City staff, and City Council have been actively involved in station design. At this stage the WSDOT would like to partner with the City of Tacoma to install a large scale, tile Historic Interpretive Display inside the New Amtrak Station, but visible from the street. The particular Historic Interpretative Display presented in Attachment B to the SPA was developed by Historic Tacoma and endorsed by the Amtrak Citizens Advisory. This Display and project background was presented to the City Council at its January 31 Study Session.

ISSUE:

The issue at hand is whether or not the City will assist WSDOT in the installation of the Historic Interpretative Display. The SPA will fully reimburse the City for all costs, costs estimated at \$233, 841 (including contingency).

ALTERNATIVES:

The alternative would be to leave the Historic Interpretative Display design and installation to WSDOT.

RECOMMENDATION:

The recommendation is that the City Council by Resolution agree to partner with the State Department of Transportation to install a Historic Interpretive Display at the New Amtrak Station at Freighthouse Square.
