SUMMARY:

The Environmental Services Department recommends a contract be awarded to PacWest Machinery LLC, Kent, WA, in the amount of \$264,655.06, plus applicable sales tax, budgeted from the ES Surface Water Fund 4301, to purchase one TYMCO 500X Street Sweeper.

STRATEGIC POLICY PRIORITY:

Strengthen and support a safe city with healthy residents.

Encourage and promote an efficient and effective government, which is fiscally sustainable and guided by engaged residents.

New sweepers are more fuel efficient than our existing fleet. The machines have Tier 4 engines that produce less air emissions per gallon of fuel than existing vehicles.

BACKGROUND:

ISSUE: Street sweeping removes road debris and materials prior to entering the City storm system and eventually the local water ways and Commencement Bay. Street sweeping is required per the City's Surface Water NPDES permit and improves not only the water quality for the area, but meets the City Council's goal of a safe, clean and livable community.

ALTERNATIVES: The alternative is to not purchase the street sweeper which will result in a reduction of service-levels, and will affect water quality as well as City and neighborhood aesthetics. Existing equipment will be subject to higher usage and will result in increased overall operating. maintenance and repair costs.

COMPETITIVE SOLICITATION: State of Washington Contract No. 02613 is a competitively solicited contract valid through August 27, 2018. This contract meets the City's competitive solicitation requirements by means of an interlocal cooperative purchasing agreement and the equipment will be purchased at the prices, terms, and conditions of this contract. The ability to participate in cooperative purchasing through state contracts provides the City increased savings by pooling resources to leverage the market through volume discounts.

CONTRACT HISTORY: New contract
