ITEMS OF INTEREST

1. Since 1987, the City of Tacoma has honored over 200 outstanding local volunteers through its City of Destiny Awards program. The City of Destiny Awards program is spearheaded by the City Council appointed City Events and Recognition Committee, comprised of local community leaders from a broad array of backgrounds and areas of expertise. This year the City Council will recognize Tacoma's top volunteers during the annual City of Destiny Awards on Friday, June 9th, at 5:30 p.m. (doors open at 5:00) The event will be held at the STAR Center, located at 3873 South 66th Street.

2. Public Works Department Director Kurtis Kingsolver provides the attached memorandum related to deployment of the City's Integrated Parking Management System. Public Works is testing a new parking management system and integrating a new warning procedure for first time offenders using the License Plate Recognition hardware and electronic handheld enforcement devices that operate in real-time environment. With the new equipment, Parking Services will realize benefits, such as: expanded enforcement coverage; operational efficiencies to allow for a focus on life safety violations; and, opportunities to educate with warnings and distribution of a pamphlet.

In addition, Community and Economic Development Director Ricardo Noguera provides the attached WorkForce Central Monthly Employment Report for Pierce County. The report shows a decreased unemployment rate of 5.3% for Pierce County, marking the lowest unemployment rate since April 2008.

STUDY SESSION/WORK SESSION

4. The City Council Study Session of Tuesday, June 6, 2017, will be held in Room 16 of the Tacoma Municipal Building North, at Noon. Discussion items will include: (1) Washington State Department of Transportation Updates on Ongoing and Upcoming Construction Projects; (2) Bring Your Own Bag Ordinance Implementation; (3) Emergency Homeless Response Update; (4) Other Items of Interest – Council Consideration Request Sister Cities Events Support; (5) Committee Reports; (6) Agenda Review and City Manager's Weekly Report; and, (7) Executive Session – Pending Litigation.

At Tuesday's Study Session, Washington State Department of Transportation (WSDOT) staff will provide an **update on the ongoing and upcoming projects being constructed as part of the Tacoma/Pierce County HOV Program**. The presentation will provide an overview of the various projects, anticipated construction timelines and upcoming traffic impacts.

As a second item at the Study Session, Environmental Services' Office of Environmental Policy and Sustainability staff will provide the City Council an **update on the Bring Your Own Bag Ordinance implementation and roll out plan.** The code goes into effect July 12th, and staff will be conducting outreach and assistance to both shoppers and retailers.

As previously shared with the City Council and the public, the three-phase approach for emergency temporary aid and shelter program will include mitigation to reduce impacts of homelessness on citizens, businesses and homeless individuals. The temporary transitional centers will provide the homeless connections to social and health services to better assist in facilitating the transition to permanent housing during this public health emergency. As a third topic on Tuesday, the Emergency Homeless Response Team will provide an update on staff's efforts for outreach, alternative shelter options and services for the homeless population.

Under Other Items of Interest, Mayor Strickland will share the attached Council Consideration Request to provide up to \$12,000 from the Council's Contingency Fund to assist the Sister City Council in covering expenses for events planned for delegations from two of our Sister Cities (Fuzhou, China and Kitakyushu, Japan) during the Festival of Sail this month.

5. The updated **Tentative City Council Forecast** and **Consolidated Standing Committee Calendars** are attached for your information.

COUNCIL MEETING

On Tuesday's City Council agenda is **Resolution No. 39742**, requesting the Planning Commission consider **amending Chapter 13.06 of the Municipal Code**, **relating to Zoning**, **on an interim basis**, **by adding local definitions of "Playground" and "Recreation center of facilities**," in order to protect Metro Parks Tacoma owned playgrounds and recreational centers and facilities to the level intended by the State, but currently not covered by State definitions. The resolution was proposed by Deputy Mayor Thoms through a Council Consideration Request discussed at the May 9th Study Session. During the discussion, the City Council requested a map illustrating the 1,000 foot buffer from Metro Park facilities and playgrounds and clarification on how a buffer is measured. In response, Planning and Development Services Director Peter Huffman provides the attached map and memorandum.

GRANT APPLICATIONS

- 7. The City has applied for the following grant:
 - Commercially Sexually Exploited Children Taskforce Support Funding to support the taskforce in focusing on the development of resources for community partners, to include: training; increasing awareness of State and Federal Laws; sharing best practices for service delivery; and, enhancing a coordinated, interdisciplinary, victim centered response. The City is requesting \$50,000, with no City match required.

The Public Works Department is testing a new parking management system and integrating a new warning procedure for first time offenders.

The new parking management system is endorsed by the City Council. The City's volunteer Parking Technical Advisory Group provided oversight throughout the procurement and system development process.

Parking Services staff and its vendor, GTechna, are readying the deployment of the enhanced parking enforcement elements of a comprehensive Integrated Parking Management System (IPMS). The enforcement system integrates a new practice to issue warnings to first time offenders, License Plate Recognition (LPR) hardware, and new electronic handheld enforcement devices that operate within a real-time environment. With implementation of the new equipment, Parking Services expects to realize the following benefits:

- Expanded enforcement coverage to provide consistent service in business districts.
- Operational efficiencies which will allow officers to focus more on life safety violations and being ambassadors for the City.
- Additional opportunities to educate with warnings and distribution of a pamphlet that shows how to avert a parking citation (see pamphlet on page two).

Parking Services plans to go live with the first phase of the new system beginning the week of June 5, 2017. Between now and then, staff will be testing the new system and rehearsing the new parking enforcement protocols.

The remaining elements of the planned IPMS requires the collaboration of other branches of the citation processing system including adjudication and collections. There are several existing systems and procedures that make this process challenging. Parking Services predicts the full implementation of the IPMS will take a few years to complete via the planned multiphase approach.

The goal is to address the following deficiencies:

- Poor payment compliance
- · Poor collection efforts
- Inability to quickly identify repeat offenders
- Inflexible and non-scalable infrastructure
- Poor customer service tools
- Inability to provide basic level reports
- Slow updating of data
- Revenue tracking

Week in Review: May 30, 2017

- ◆ Downtown Trolley. A collaboration formed between Pierce Transit, Metro Parks, City of Tacoma and other local partners is set to launch this coming Friday, June 2nd beginning with a rally at Tollefson Plaza. This trolley will run Friday through Sunday from 10 a.m. through 8 p.m. and run through Labor Day. The ultimate goal of the trolley service is to provide transit services for local area residents and Downtown visitors to Ruston Way restaurants, Point Ruston and Point Defiance Zoo & Aquarium; showcase Tacoma's waterfront amenities while reducing vehicular traffic along Ruston Way.
- ◆ Lincoln District Open House. The City will host an Open House at its Lincoln District office on 38th Street on June 7th from 3-7 pm. The City's Public Works Department expects to issue a Notice to Proceed on either June 12th or 19th; area businesses and property owners continue to be notified by CEDD staff.
- ◆ Private Developers Continue to Pursue 12-Year Multi-Family Exemptions. A total of six private developers have submitted plans in 2017 thus far representing 77 affordable units. The increase in 12-Year MFPTE's is partially due to city staff's continued promotion of this program to local developers and inviting them to consider the benefits of participating in a lengthier tax abatement program and supporting affordable housing.



UNEMPLOYMENT

WorkForce Central reported a decrease in Pierce County's unemployment rate in April 2017, 0.4 percent lower than the revised March 2017 rate (5.7 percent) and 1 percent lower than the year-ago estimate (6.3 percent).

The unemployment rate is 5.4 percent below the highest April unemployment rate (10.7 percent in 2010) but remains 0.7 percent higher than the lowest April unemployment rate experienced in the region over the last 10 years (4.6 percent in 2007).





MONTH-OVER JOB CHANGES¹

Five industries experienced monthover employment gains. Construction experienced the largest month-over gain, adding 1,000 jobs. Trade, Transportation & Utilities added 900 jobs, Professional & Business Services added 500 jobs, Government added 400 jobs and Other Services added 100 jobs.

Five industries (Educational & Health Services, Leisure & Hospitality, Natural Resources & Mining, Information and Manufacturing)² showed no change, and one industry (Financial Activities) experienced a month-over loss of 100 jobs. Overall, employers in Pierce County have added 2,800 net jobs in the past month.

YEAR-OVER JOB CHANGES

From April 2016 to April 2017, seven industries experienced job growth. Trade, Transportation & Utilities continues to have the greatest year-over gains, adding 3,500 jobs to the region. The main source of job growth in this sector comes from Retail Trade, adding 3,400 jobs. Professional & Business Services added 2,000 jobs, Construction added 1,400 jobs, followed by Educational & Health Services with 1,100 jobs. Financial Activities, Government and Other services also saw job gains.

Information experienced no year-over changes, while three industries showed year-over job losses: Leisure & Hospitality (down 600 jobs), Manufacturing (down 400 jobs) and Natural Resources & Mining (down 200 jobs). Overall, employers in Pierce County have added 7,900 net jobs in the past year.

SUMMARY

Most industry sectors in Pierce County experienced both month- and year-over job gains in April. Pierce County has also gained a net of 2,800 jobs from March 2017 and 7,900 jobs since April 2016. However, Pierce County's unemployment rate of 5.3 percent is 1 percent higher than Washington's rate of 4.3 percent.³

ITEM/ISSUE PROPOSED FOR COUNCIL CONSIDERATION:

I ask for your support for the inclusion of the following item on the agenda at the earliest available meeting of the Study Session:

I respectfully request City Council concurrence to direct the City Manager to allocate up to \$12,000 from the City Council Contingency Funds to support the Sister Cities Council for expenses incurred for Sister Cities events in June, 2017.

BRIEF BACKGROUND:

The Sister Cities International program was created in 1956 at President Eisenhower's White House conference on citizen diplomacy. The goal was to create bonds between people in different cities all around the world in the hope that doing so would result in peace and prosperity. Sister Cities programs advance positive international relations between cities through arts, educational, cultural, and trade exchanges.

Tacoma has 14 Sister Cities, and maintaining those relationships is the responsibility of local volunteer committees led by the Sister Cities Council. Mayor Strickland extended a letter to the mayors of our Sister Cities encouraging them to come to Tacoma for the Festival of Sail events, scheduled for June 15—18, 2017. Delegations from Fuzhou, China, and Kitakyushu, Japan, have confirmed that they plan to attend. The Sister Cities Council has been working to raise funds to cover expenses to be incurred in the course of planned events for the visiting delegations. The requested funding of up to \$12,000 would help support the Sister Cities Council and their volunteers to cover expenses related to the planned events.

The requested support for the Sister Cities Council aligns with the City's Tacoma 2025 goals of Economy/Workforce and Livability.

FUNDING REQUESTED:

Up to \$12,000 to be set aside for the Sister Cities Council to pay for expenses related to events organized by Sister Cities volunteers for visiting delegations.

On June 6, 2017, the City Council will consider adopting a resolution to initiate the process for enacting interim regulations that would add local definitions of "Playground" and "Recreation center or facility" to the Tacoma Municipal Code pertaining to buffer zones for marijuana uses. The intent is to protect Metro Parks Tacoma owned playgrounds and recreational centers and facilities to the level intended by the State, but currently not covered by State definitions. The resolution is in response to the Council Consideration Request (CCR), dated May 4, 2017, submitted by Deputy Mayor Thoms.

The CCR was reviewed and discussed by the Council at the study session on May 9, 2017. The Council requested staff to provide (1) mapping illustration of the 1,000-foot buffer from Metro Parks facilities and playgrounds, and (2) clarification on how the buffer is measured from a parcel that contains play structure.

Regarding the buffer zone mapping, in staff's original analysis of the buffer zones as set forth in Amended Ordinance No. 28361, adopted on May 24, 2016, playgrounds, for mapping purposes, were included and assumed to be in all parks, including those owned by Metro Parks. Attached is a map depicting the locations of currently operating marijuana businesses (including retailers, producers and processors), along with applicable buffer zones. The map also denotes the locations of Metro Parks owned parks that contain playground equipment, and those parks are already located within the mapped buffer zones. While the City's preliminary mapping already included those sites, adding definitions of "Playground" and "Recreation center or facility" to the code, as proposed, will help ensure that all public playgrounds are buffered, as was intended.


It is also noted that the interactive "I-502 Zoning Map" tool provided for prospective license applicants on the Tacoma Permits website (http://tacomapermits.org/marijuanamap) was created based on commonly available data. While the City of Tacoma believes this information is generally accurate, it is clearly indicated that it's the applicants' responsibility to independently verify that their sites are not located within required buffers as outlined in TMC 13.06.565 and WAC 314-55. Locations marked as compliant and non-complaint are not officially reviewed by the City of Tacoma until an application from the Washington State Liquor and Cannabis Board is provided to the City.

With regards to the buffer measurement, per State law the buffer is measured as a straight-line distance ("as the bird flies") from the closest edges of two parcels — the parcel that contains the protected/buffered use and the parcel that is proposed for the marijuana use. Thus, in the circumstance of a Metro Parks owned playground, the buffer is not measured from the actual play equipment, it is measured from the edges of the park property.
