### SUMMARY:

On April 12, 2017, the Infrastructure, Planning, and Sustainability Committee met and interviewed several candidates for the Sustainable Tacoma Commission.

After interviewing the candidates, Christina Cooley was reappointed, and Tamelia Sheree Cooks, Chris Karnes, and Jaclyn Layton were appointed to the Commission.

In early May, another vacancy occurred on the Commission. Chair Mello requested the applicants, who were interviewed, but not recommended, and still interested from the April 12, 2017 interviews, be reconsidered for this additional vacancy.

Five applicants <u>not</u> recommended at the April 12, 2017 meeting were: Matthew Benedict, Zachary Christin, Todd Hay, Emily Kalnicky, and Colin McCann.

The City Clerk's Office contacted the applicants to see if they were still interested in being considered for the vacancy. Zachary Christin is now employed with the City, making him ineligible, and Emily Kalnicky did not respond.

### **BACKGROUND:**

The Sustainable Tacoma Commission works with the Office of Sustainability, which is responsible for implementing the strategies in the Climate Action Plan and measuring the city's progress as it reduces greenhouse gas emissions. Both the Office and the Commission were created by a City Council resolution in October 2008.

The Sustainable Tacoma Commission consists of eleven members appointed by the City Council. Membership is a balanced representation of stakeholders, such as the environmental community, small business, labor, housing, industry and port, transportation, education, building industry, and residents.

The Commission oversees implementation of Tacoma's Climate Action Plan as the City and community reduce greenhouse gas emissions. It is intended to bring citizen accountability, transparency, and vigilance to the long-term implementation of Tacoma's Climate Action Plan, as developed by the Green Ribbon Climate Action Task Force.

### ISSUE:

One position needs to be filled.

### **ALTERNATIVES:**

The Commission will continue to operate without full membership.

### FISCAL IMPACT:

There is no fiscal impact.

# **RECOMMENDATION:**

Staff requests that the Infrastructure, Planning, and Sustainability Committee recommend the appointment of one member to the Sustainable Tacoma Commission, which would be forwarded to the full City Council on June 27, 2017.
