Briefing Items

2. 17-0474

Bring Your Own Bag Implementation [Kristin Lynett and Jim Parvey, Office of Environmental Policy and Sustainability]

At approximately 4:32 p.m., Jim Parvey, Environmental Services Division Manager, introduced Kristin Lynett, Sustainability Officer, and Emily Campbell, Project Specialist. He stated that Bring Your Own Bag implementation will be effective on July 12, 2017. Kristin Lynett noted

twelve month preparation was needed and the project is on track and provided information on Bring Your Own Bag, including background, retailer engagement, marketing process, retailer and shopper resources, many ways of outreaching to shoppers and events, enforcement, and next steps.

Discussion ensued throughout the presentation regarding point of sale information, multilingual marketing resources, utilizing Pierce Transit and Point Defiance Zoo for marketing, drop-off locations, difficulties with outreach, utilizing the inventory, and reminders to the community.

3. <u>17-0475</u> Environmental Services Strategic Plan Update [Shane Pettit and Jessica Knickerbocker, Environmental Services]

At approximately 4:50 p.m., Mike Slevin, Director, Environmental Services, gave credit to the current 2013-2018 Strategic Plan and noted the team's hard work and bottom-up approach program, which is led by the staff. He then introduced Jessica Knickerbocker and Shane Pettit, Environmental Services Leads, to present the 2018-2025 Environmental Services Strategic Plan.

Ms. Knickerbocker provided an overview of the planning team goals, including key points, approach, strategies, and the plan. Mr. Pettit presented the planning process, including research, outreach, development, and plan, noting the implementation stage will anticipate to begin by January 1, 2018. He then stated the Key Outreach Event will be held on June 1, 2017, at Urban Waters, to provide information, observe, and ask questions. Director Slevin added that there is a consultant on board to help with facilitating the internal staff.

Discussion ensued throughout the presentation regarding which divisions are involved and how all of the different plans are tied together.
