Council Member Mello thanked City Manager Elizabeth Pauli and staff for the outreach and adaptive management of the homelessness crisis and requested she provide a summary and feedback gathered from the many community meetings she has attended on this issue.

Council Member Lonergan stated there are also two vacancies on the City Events and Recognitions Committee and encouraged everyone to apply. He then announced a community cleanup on Saturday, July 29, 2017, from 10:00 a.m. to 1:45 p.m., at Larchmont Elementary School.

Mayor Strickland announced a Tacoma Works job fair at 6:00 p.m. on Thursday, July 27, 2017, at the Salishan Family Investment Center, for family-wage job opportunities in the construction field, including contractors and educational, non-profit, and apprenticeship organizations.
