The services to be purchased included a callaboration with both faculty and students at the University of Washington at Tacoma to provide 35,000-85,000 hours of technical assistance, research, education, and public outreach for various projects throughout the City to develop solutions. The impact will include 30 comprehensive plans reports

addressing various concerns throughout the City.

For your review and recommendation.

In accordance with TMC 1.06.256 (B), City Manager's Office requests a waiver of the competitive solicitation process and authorization to directly negotiate with **The University of Washington at Tacoma**, for technical assistance, research, education, and public outreach for various projects throughout the City to develop solutions, in the amount of \$350,000, plus applicable sales tax.

Direct negotiation approval constitutes a waiver of further competitive solicitation for amendments to the subject contract provided that any such amendment(s) shall be signed by personnel as authorized in the Delegation of Procurement Signature and Approval Authority memorandum. Contract totals shall not exceed \$200,000 without City Council or Public Utility Board approval as appropriate.

EXPLANATION: In collaboration with the University of Washington, students from various disciplines will embark on a range of projects throughout the City of Tacoma. The scope of the projects can be the following: infrastructure, programmatic, or service oriented. The commitment is for the academic year of 2017-2018.
