Dear Mayor and Council Members:

ITEMS OF INTEREST

- 1. Planning and Development Services Director Peter Huffman reports that on August 16th the Tacoma Planning Commission released draft Tideflats Interim Regulations for public review and comment and set a public hearing for September 13th at 6:00 p.m., at the Greater Tacoma Convention Center. The public review draft of the interim regulations (available beginning the week of August 21st at www.cityoftacoma.org/planning) would do the following: 1) Prohibit new non-industrial uses and expansion of existing non-industrial uses within the Port of Tacoma Manufacturing and Industrial Center; 2) Prohibit new residential units and platting along the slopes above Marine View Drive; 3) Expand public notification for heavy industrial uses city-wide that require discretionary permits or SEPA environmental review; and, 4) Prohibit, city-wide, the establishment of the following new heavy industrial uses:
 - Coal terminals and coal bulk storage facilities;
 - Oil or other liquefied or gaseous fossil fuel terminals, bulk storage, manufacturing, production, processing or refining;
 - Chemical bulk storage, production, processing, and acid manufacturing;
 - Smelting; and
 - Mining and quarrying.

The draft proposal and initial findings of need for interim regulations within the Port of Tacoma Manufacturing and Industrial Center was developed in response to Amended Resolution No. 39723, adopted on May 9, 2017, which initiated both the interim regulations discussion and the Tideflats Subarea Plan. STUDY SESSION/WORK SESSION

4. The City Council Study Session of Tuesday, August 22, 2017, will be held in Room 16 of the Tacoma Municipal Building North, at Noon. Discussion items will include: (1) Puyallup Land Claims Settlement Agreement; (2) Emergency Temporary Aid and Sheltering Three-Phase Approach Update; (3) Other Items of Interest – Proposed Amendments to Tacoma Municipal Code Title 18; (4) Committee Reports; and, (5) Agenda Review and City Manager's Weekly Report.

At Tuesday's Study Session, John Bell, Legal Counsel, for the Puyallup Tribe of Indians, will give a presentation on the Puyallup Land Claims Settlement Agreement between the Puyallup Tribe of Indians, Pierce County, Tacoma, Fife, Puyallup, Port of Tacoma, State of Washington, United States of America, and certain private property owners.

As a second item on Tuesday's Study Session, there will be a **briefing on the City's Emergency Temporary Aid and Sheltering Three-Phase Approach, to include a status update on the first three months of the plan since the Emergency Declaration**. The purpose of this update is to satisfy the requirement of Ordinance No. 28430. This ordinance, passed by the City Council on May 9, 2017, declared a state of public health emergency relating to the conditions of homeless encampments, and required that the City Council review the conditions that have given rise to this public health emergency to determine if such conditions warrant keeping in place the extraordinary measures authorized herein to respond to this public health emergency.

Under Other Items of Interest on Tuesday, I will be sharing with the City Council that at the August 29th Study Session, there will be a discussion, with Tax and License staff from the Finance Department available, to address questions and concerns related to Ordinance No. 28449, which was removed from the agenda last Tuesday to amend Title 18 of the Tacoma Municipal Code based on the State's paid sick leave law.

REQUESTS/INQUIRIES

6. At last Tuesday's City Council meeting, Council Member Mello inquired about the feedback staff is receiving while they are attending the various community outreach meetings to provide updates on the City's homeless plan. Staff provides the following response.

In response to growing health concerns from higher concentrations of people living in more than 50 encampments across Tacoma, the City Council declared a state of public health emergency on May 9th, 2017, and began implementing an Emergency Temporary Aid and Sheltering Plan. Since that time, City Staff has attended and presented to ten community groups to inform residents and receive feedback.

At the community meetings, Staff has provided detailed answers to questions and concerns and has incorporated feedback received into the City's strategies. Much of the feedback from community members has come in the form of questions asked during the presentations, which included themes such as:

- How will this emergency declaration affect the City's ability to mitigate the effects of homeless on people experiencing homeless and the community?
- How long will the emergency declaration last?
- How much will the emergency cost in the short and long term?
- How well is this new approach working?

The most vocal feedback came from meetings that took place early in the Plan's implementation process with the Dome Business District, the East Abe's and Lincoln South Safe Streets groups and the Dometop Neighborhood Alliance. These groups vocalized concerns about the lack of citizen involvement in the decision to locate the City's Stabilization Site at 1423 Puyallup Avenue and were concerned about a rumor that the City was considering locating another site on City property located at 35th and Pacific Avenue. The groups also voiced concern over whether going forward the City would unilaterally choose to locate other sites in their respective neighborhoods. Staff listened and responded to the concerns and explained why the initial steps were taken so rapidly to mitigate and address health and safety issues. Staff assured residents that the City would provide earlier and more comprehensive outreach with affected neighborhood groups should future locations be established.

In response to these initial concerns, City Staff established a stakeholder group (a community advisory committee) in the Dome District and has met with the group four times. City Staff has built strong relationships with the community stakeholders, and opinions of the City's efforts surrounding the Emergency Aid and Temporary Sheltering Plan have become increasingly positive.

Since the initial community group feedback, many of the remaining community group meetings have been positive - with attendees expressing their appreciation for the City's efforts in managing the impacts of the stabilization site on business and residential neighbors. They have also appreciated the enforcement efforts related to illegal activity, and the rapid response to addressing and clearing homeless encampments throughout the City.

ECONOMIC DEVELOPMENT WEEKLY UPDATE REPORT Week of August 21, 2017

1st Micro-Unit Development in Tacoma Breaks Ground

KOZ Development, a Snohomish County housing developer will host a ground breaking ceremony on Wednesday, August 23rd at 3 pm at the site of their planned project (17th/Market) just across the street from the University of Washington -Tacoma (UWT) YMCA and the first residence supporting the campus. This 107-unit project will contain no parking and is ideally suited to support UWT students as well as downtown workers. The project will also include 20 percent of the units at the affordable rate (12-Year Multi-family Property Tax Exemption) and include ground floor retail, ideally suited toward a restaurant or café to support a growing and hungry campus.

HQC USA LLC - Mixed Use Project 1210 Tacoma Avenue South

The Community and Economic Development Department negotiated a Purchase, Sale and Development Agreement with HQC USA LLC, of Renton, WA to develop a 166 unit mixed use project at 1210 Tacoma Avenue South, the current parking lot for the main library. This is not an EB-5 project, rather financed completely with capital from the developer. This estimated \$40 million development will turn a non-taxed, underutilized parking lot into a thriving home for 300 people, including 34 affordable units and adding ground level retail amenities. It will positively impact development and investment opportunities, increase the City's tax base and create about 90 full-time construction jobs.

- City Council presentation December, 2016 PSA approved.
- PSA signed December, 2016.
- Presentations to Library Board on December 21, 2016, June 15, 2016, April 19, 2017 and July 19, 2017
- Environmental study limited phase II complete and monitoring wells installed.
- First amendment to PSA finalized on 7/72017.
- Sale of lot completed on 7/28/2017.

Current Status:

- Shoring and site development permits submitted and under review
- 12 year property tax exemption application submitted, to council on 8/29/2017
- Timeline is still to begin construction on October 1, 2017 and complete by September 1, 2019.

Next Steps:

- Continue to finalize plan to relocate current library employee parking to temporary location during construction by October 1, 2017
- Work with library on purchase of new trailers and relocation of materials to Mottet Branch parking lot by October 1, 2017
- Ground breaking October 20, 2017 with guests from Vietnam
