## **ITEMS OF INTEREST**

- 1. **Economic Development Weekly Update Report** Please see the attached update report on projects and initiatives from the Community and Economic Development Department for the week of September 11, 2017.
- 2. Planning and Development Services Director Peter Huffman provides an update regarding the Tacoma Presbyterian Church located at 5 South G Street. A demolition permit was issued June 13, 2017, for this church. During the permit process, the Landmarks Preservation Commission reviewed the project's Cultural Resource Management Plan and demolition was approved with comments. On September 8, 2017, a right of way utility permit was approved to cut and cap a Puget Sound Energy gas line in the alleyway. Based on information provided by the developer, asbestos abatement will begin the week of September 18<sup>th</sup> with a duration of approximately two weeks. Structure demolition is expected to be complete by the end of October. The developer is working with the State Department of Archaeology and Historic Preservation to comply with the reporting requirements. The Monitoring and Inadvertent Discovery Plan is being reviewed by the City's Historic Preservation Office (HPO). The developer will engage with the Tacoma Preservation Office as necessary to obtain design review approval for any future building to ensure compatibility with the surrounding built environment. Future plans for the site are still in development. The developer will continue to communicate with the City's HPO as they progress through the process, and the City Manager will continue to be updated.

## STUDY SESSION/WORK SESSION

Five years ago Environmental Services became a new department and implemented the **2013-2018 Environmental Services Strategic Plan**. The 2013-2018 Strategic Plan was developed in the Director's Office with the goal of communicating the Director's vision for the Environmental Services staff. As the timeline of this first departmental plan approaches completion, the Environmental Services Department (ESD) is taking the next steps to implement a strong strategic plan that supports the Tacoma 2025 Citywide Vision & Strategic Plan. The department is broadening the approach for the 2018-2025 Strategic Plan to have the development and implementation efforts led by staff.

Research efforts, which were conducted earlier this year, included reviews and presentations on Tacoma 2025, the Equity & Empowerment Framework, the Environmental Action Plan, and the current 2013-2018 Environmental Services Strategic Plan. The Department is currently undertaking an outreach phase to incorporate feedback and involvement from stakeholders and employees. These outreach efforts include stakeholder interviews, employee surveys & focus groups, assimilating data from customer surveys, and a workshop with the Environmental Services Commission which represents residential, commercial, industrial, and governmental sectors. Information collected from the research and outreach phases will be utilized in the outlining and drafting of the strategic plan. A final draft of the 2018-2025 Environmental Services Strategic Plan is anticipated in the 4<sup>th</sup> Quarter of 2017, with implementation beginning in January 2018.

ESD is continuing to conduct outreach and has started the development phase to create an outline of priorities. At Tuesday's Study Session ESD staff will provide an **update on the research**, **outreach**, **and development efforts**, **and give an overview of next steps**.

As a second item on Tuesday's Study Session agenda, Finance Department staff will provide an **update on approaches utilized for financial planning and an updated financial forecast through 2020**.

## ECONOMIC DEVELOPMENT WEEKLY UPDATE REPORT

## Week of September 11, 2017

#### Oak Trace Affordable Housing Development:

This coming Saturday, September 16<sup>th</sup> at 2:00 p.m., Von Bay Construction, a private development company focused exclusively on developing affordable housing, will celebrate the grand opening of this project. The project consists of 130 affordable housing units reserved for household earning from 30-50% of the area median income. The project is ideally situated across the street from Mount Tahoma High School along 74<sup>th</sup> Street in South Tacoma. The event will take place at 7419 S. Verde Street. This project represents the second affordable housing development to celebrate a grand opening within the past two months; Bay Terrace II celebrated its grand opening in late August.

#### Amazon H2Q:

Community and Economic Development Department is working with the Economic Development Board, Tacoma Public Utilities, University of Washington Tacoma, and others to respond to the nationwide Request for Proposals (RFP) for the second Amazon headquarters, which is due on October 19, 2017. Last Friday, on September 8<sup>th</sup>, Amazon released an RFP inviting cities, counties, states and provinces to be "creative" and submit proposals to support their second headquarters location. They're initially seeking a community which can accommodate 500,000 square feet of Class A office space with growth potential to support up to 8,000,000 square feet over a 15+ year period. Amazon proposes to invest \$5 billion in capital expenditures and hire more than 50,000 workers who could earn, on average, more than \$100,000 annually.
