8	of the following legally described right-of-way area:
9	That portion of the Southwest Quarter of the Northeast
10	Quarter of Section 10, Township 20 North, Range 03 East
11	of the Willamette Meridian, more particularly described as follows:
12	That portion of East 29th Street air rights lying easterly of the
13	east margin of Portland Avenue extended between a point
14	marking the Northeast corner of a parcel conveyed to the City of Tacoma as recorded under Auditor File Number
15	8508260151, records of Pierce County, Washington, said point being 18 feet east of the Northwest corner of Block 7946
16	of the Indian Addition to the City of Tacoma, according to the
17	Plat thereof filed on May 1, 1896 in Book 7 of Plats at pages 30 and 31, records of Pierce County, Washington and the
18	Southwest corner of Lot 2, Block 7945 of said plat and lying
19	westerly of a line extended from the Southeast corner of Lot 24 of said Block 7945 to the Northeast corner of Lot 24 of
20	Block 7946, beginning at a minimum vertical distance of 24.6 feet above as measured perpendicular to the finished
21	street grade.
