ITEMS OF INTEREST

- Economic Development Weekly Update Report Please see the attached update report on projects and initiatives from the Community and Economic Development Department for the week of October 16, 2017.
- 2. On Wednesday, October 18, 2017 the Planning Commission took final action to recommend to the City Council to adopt the Tacoma Mall Neighborhood Subarea Plan as an element of the Comprehensive Plan, to expand the Tacoma Mall Neighborhood Regional Growth Center by 116 acres, and to adopt zoning, design standard, transportation and pedestrian access code changes to support the vision and goals of the Subarea Plan. Concurrent with the Subarea Plan, the City has prepared an Environmental Impact Statement which will streamline procedures for future project-level review of development that is consistent with the Subarea Plan. Staff are currently assembling and finalizing the documents to reflect the Commission's direction on a final list of changes to reflect public input. The Commission's final recommendation package will be available the first week of November. On Tuesday, November 21st, staff will present the full recommendation package at the study session, prior to the Council's public hearing which is tentatively scheduled for that evening. COUNCIL MEETING

6. On Tuesday's Council agenda is Resolution No. 39849 for your consideration. If adopted, this Resolution would authorize the use of up to \$50,000 of City Council Contingency Funds for the creation of a Deportation Defense Subfund to assist indigent Tacoma residents, who are facing deportation, with access to legal counsel at deportation hearings. In addition, the resolution would direct the City Manager to conduct a request for proposals from entities when the subfund has reached \$100,000 or three months have passed (whichever occurs first); and, would direct the City Manager to execute a professional services agreement outlining the scope of work and deliverables. For additional information, please see the attached FAQ document with responses to questions that were raised during prior discussions at the Community Vitality and Safety Committee meeting.

On October 17, the City Council held a public hearing on the Planning 7. Commission's Findings and Recommendations pertaining to the Tideflats Interim Regulations. Northwest College of Art and Design (NCAD) – Grand Opening and Ribbon Cutting Ceremony.

Yet another grand opening celebration in Downtown Tacoma. On November 1st from Noon to 1:00 p.m., the Northwest College of Art & Design (NCAD) will welcome the Tacoma-Pierce County community and beyond to its new Downtown Tacoma campus, located at 1126 Pacific Avenue, Suite 101. The new downtown campus is designed to position the College for long-term growth, and to give students access to both resources and career development opportunities. The college recently relocated from Poulsbo to Downtown Tacoma and will continue serving students throughout Pierce, Thurston, Mason and King Counties.

The College will offer a Bachelor of Fine Arts (BFA) in Visual Communication and double majors in Entertainment Art, Graphic Design, Illustration, Interactive Design, and Motion Design. It will also offer A.O.S. degrees in Graphic Design, Web Design, Web Development, User Experience (UX) Design, and Concept Art.

Initially, there will be approximately 15 adjunct professors teaching at the College and anticipated enrollment initially will be 85. The NCAD will be an excellent addition to Tacoma's growing artist community.

Deportation Defense Subfund-Frequently Asked Questions

Creation of the Subfund

If Resolution No. 39849 is adopted, the City Council would allocate \$50,000 towards the creation of this Deportation Defense Subfund. The sponsoring Council Members realize this will not be enough to help all the individuals in our community facing deportation, so the subfund will be established so that community members can contribute by sending a check to the City Treasurer's Office with the subject line Deportation Defense Subfund, or can contribute online. Upon the City Council adoption of this resolution, the online payment option will go live or soon thereafter.

Distribution

If the resolution is adopted, the Office of Equity and Human Rights (OEHR) will oversee the distribution of this subfund. Once three months have passed, or the amount in the subfund has reached \$100,000 (whichever comes first), OEHR will issue a Request for Proposals for an entity to administer a grant from the subfund.

Eligibility

The requirements on eligibility are that individuals being served are able to prove they resided in Tacoma prior to facing deportation, and meet the income standards to be considered indigent, and thus not able to obtain private legal counsel. As there are limited funds and great demand, this fund shall only be used for legal counsel for individuals facing deportation, and not for any other legal services. These eligibility requirements will be enforced by the entity that is ultimately granted the contract.

Regarding residency requirements after being released from the Detention Center, the City does not have resources to monitor where individuals would live if they are successful at the hearing and released. In addition, there are no resources available to enforce a requirement of continued residency in Tacoma.
