A RESOLUTION relating to surplus property; declaring certain real property owned 1 by the Department of Public Utilities, Light Division (d.b.a. "Tacoma Power"), 2 consisting of approximately 1,875 square feet of property located at 543 North Stadium Way, in Tacoma, Washington, surplus to the needs of 3 the City; and authorizing the negotiated sale and conveyance of said property to Ronald L. and Linda R. Coleman for the amount of \$72,100. 4 5 WHEREAS the City of Tacoma, Department of Public Utilities, Light 6 Division (d.b.a. "Tacoma Power"), owns approximately 1,875 square feet of 7 property located at 543 North Stadium Way, in Tacoma, Washington ("Property"), 8 as more fully described in the documents on file in the office of the City Clerk, and 9 WHEREAS in 2009, pursuant to Utility Board Resolution U-10270, the 10 11 Property was declared surplus to Tacoma Power's needs, and 12 WHEREAS Ronald L. and Linda R. Coleman have offered to purchase the 13 Property for \$72,100, which is deemed acceptable by Tacoma Power and the 14 Department of Public Works, Real Property Services Division, and 15 WHEREAS a restrictive covenant will be included in the quit claim deed 16 17 prohibiting development of the Property, and 18 WHEREAS the Department of Public Works proceeded with the negotiated 19 disposition process pursuant to Tacoma Municipal Code ("TMC") 1.06.280.F, and 20 WHEREAS, on October 11, 2017, by adoption of Public Utility Board 21 Resolution No. U-10961, the Property was approved for sale, pending confirmation 22 23 from the City Council, and 24 25 26 - 1 -

2	TMC 1.06.280, the City Council conducted a public hearing on the proposed sale

4	WHEREAS, there being no foreseeable need for continued City ownership
5 6	of the Property, the sale of said Property appears to be in the best interests of
7	the City, pending final approval from the City Council; Now, Therefore,
8	BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:
9	Section 1. That continued ownership of approximately 1,875 square feet
10	of property located at 543 North Stadium Way, in Tacoma, Washington, owned
11	by the City of Tacoma, through its Department of Public Utilities, Light Division,
12 13	is not essential to the needs of the City and is hereby declared surplus pursuant
14	
15	to RCW 35.22.020 and Article I, Section 1.2, and Article IX of the Tacoma City
16	Charter.
17	Section 2. That the proper officers of the City are hereby authorized to
18	execute all documents necessary, including a Quit Claim Deed, to convey the
