#### **Economic Development Committee**

He reported on October 24, 2017, staff presented the historic buildings relationship to economic development in downtown Tacoma; the Economic Development Advisory Group "Light Up Tacoma" initiative; and the 2017 pilot for the Dome to Defiance trolley. Finally, Chair Campbell stated on October 31, 2017, staff presented on the Sister City Program, the Special Events Program, and Spaceworks. He concluded by stating the next meeting is November 14, 2017, and will include interviews for the Tacoma Arts Commission and an update on multifamily property tax exemptions.
