2. <u>17-1168</u> Tacoma Arts Commission Interviews [Doris Sorum, City Clerk]

At approximately 10:07 a.m., Doris Sorum, City Clerk, introduced the candidates to be interviewed for the available positions on the Tacoma Arts Commission. The Committee interviewed Rosie Ayala, Burl Battersby,

RJ Casey, William Elder, Heide Fernandez-Liamazares, Paula Jacobson, Aidan Kelly, Kristina Sutton, and Michelle Douglas.

Discussion ensued regarding the potential candidates.

3. 17-1169 MultiFamily Property Tax Exemption (MFPTE) Update.

[Debbie Bingham, Program Development Specialist, Community and Economic Development]

At approximately 11: 24 a.m., Debbie Bingham, Program Development Specialist, Community and Economic Development, introduced Chuck Depew, National Development Council, who advises government entities on investments in social infrastructure. Ms. Bingham discussed the current market conditions of leasing rates through September 2017 and the use of the Multi-Family Property Tax Exemptions (MFPTE) for 8-year and 12-year developments. Mr. Depew presented the residual land value analyst providing the initial result assumptions, and changes to rent and construction with the impact of the land value. Ms. Bingham stated alterations to the exemption have been considered but are not feasible at this time; however, there are recommendations to promote the 12-year exemption in different ways, while continuing to monitor the development data for future changes to the MFPTE policy.

Discussion ensued regarding the affordable housing aspect compared to the MFPTE policy.
