8 WHEREAS the need for the consultant services contract could not have been foreseen or reasonably evaluated at the time the City adopted its biennial budget, and

WHEREAS Ordinance No. 22569 requires an affirmative vote of not less 12 13 than six members of the Council in order to withdraw moneys from this fund; Now, 14 Therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

Section 1. That the Rules of Procedure of the Council of the City of Tacoma 17 is hereby amended as follows: amending Rule 9, relating to Public 18 19 Comment/Public Forum, by striking revising the existing Section C, Citizens' 20 Forum - Second Tuesday, and replacing it with a one-year Pilot Project, all as 21 more specifically set forth in the attached Exhibit "A." 22

Section 2. That one-time funding, in an amount up to \$25,000, budgeted 23 from the City Council Contingency Fund, is hereby approved for the purpose of 24 25 funding a contract with the Center for Dialog and Resolution to assist in evaluating 26

5	RULE 9 – PUBLIC COMMENT/PUBLIC FORUM
6	* * *
7	C. Citizens' Forum - Second Tuesday. On the second Tuesday of each month, time shall be reserved for citizens' comments. The purpose of this forum is to
8	assist the Council in making policy decisions; therefore, items of discussion shall be limited to matters over which the City Council has jurisdiction. A
9	speaker's remarks shall be limited to up to three minutes per person, per Citizens' Forum. Where necessary, due to the number of persons who want to
10	address the Council, the presiding officer shall retain authority to limit all
11	persons' remarks to an equal period of less than three minutes. To further ensure equal opportunity for the public to comment, each person may address
12	the Council only one time during the Citizens' Forum portion of any meeting. Comment shall not be made in support of or opposition to any matter on the
13	Council Agenda for which the time for public comment has passed <u>when</u> meetings are held during regular Council meetings in Council Chambers.
