2. <u>17-1273</u> 2017 Entrance Utilities Audit [Olga Darlington, CPA, Moss Adams]

At approximately 4:36 p.m., Susan Calderon, Assistant Director, Finance, made opening remarks and introduced Olga Darlington, Moss Adams.

Ms. Darlington provided an overview of the 2017 audit for the Tacoma Public Utilities and Environmental Services funds, including the engagement team; communication with those charged with governance, noting direct access to the Committee, an audit entrance presentation, and an audit exit and final report presentation; phases of the audit and timeline; scope of services; responsibilities under auditing standards; management's responsibilities; areas of emphasis in risk assessment; and new accounting standards.

Discussion ensued regarding the use of government auditing standards.

Chair Lonergan thanked the staff of Moss Adams for their consistency with the audits and expressed appreciation to the Audit Advisory Board members.

3. 17-1274 Job Tax Credit
