RECOMMENDATION SUMMARY:

The Information Technology Department recommends a contract be awarded to Cerium Networks, Spokane, WA, for Avaya Maintenance and Support Services, in the amount of \$454,859.05, plus any applicable taxes, for an initial contract term of three years with the option for two additional one-year renewal terms, for a projected contract amount of \$772,449.21.

STRATEGIC POLICY PRIORITY:

- Ensure all Tacoma residents are valued and have access to resources to meet their needs.
- Encourage and promote an efficient and effective government, which is fiscally sustainable and guided by engaged residents.

This contract assures the Information Technology Department continues to operate and maintain the General Government voice communications system to ensure continued support for critical City business operations and communications with the citizens of Tacoma.

BACKGROUND:

ISSUE: The Information Technology Department utilizes Avaya maintenance and support services for hardware maintenance, software updates, and support services for the General Government voice communications system. This contract also provides for 24/7 remote monitoring, troubleshooting, diagnostic support, programming assistance, and on-site services as-requested.

ALTERNATIVES: Forgoing Avaya maintenance and support services would pose considerable risk to City business operations and communications with the citizens of Tacoma and therefore is not recommended.

COMPETITIVE SOLICITATION:

Request for Proposal Specification No. DOC1158856407, Avaya Maintenance and Support Services was opened January 16, 2018. Four companies were invited to bid in addition to normal advertising of the project. One submittal was received. By contracting with Cerium Networks, an Authorized Avaya Business Partner, the City receives a 38.5% hardware and 36.5% software discount level off the Avaya list prices. In addition, Cerium Networks provides a 35% discount to the City for any scheduled Avaya Administration class provided at the Cerium Learning Center for the contract duration.
