**Briefing Items**

**Bring Your Own Bag Outreach Overview – Kristi Lynett, Sustainability Officer**

Kristi gave an overview of the outreach being done for the Bring Your Own Bag ordinance. Commissioners were asked to give staff the names of any places where more bags can be given out.

### **Urban Forestry Preservation Codes Presentation – Mike Carey, Urban Forester**

Mike gave a PowerPoint presentation of the Urban Forest Preservation Codes. He pointed out several codes and policies that pertain to public and private trees are conflicting and need to be resolved. Handouts were provided.

- 9.17 – Private Use of Street Right of Way
- 9.18 – Trees & Shrubs – Trimming and Removal
- 9.19 – Trees & Shrubs – Planting
- 9.20 – Trees & Shrubs – View Blockage
- 13.06 – Landscape & Buffering Standards
- 13.13 – Critical Areas Preservation

Discussion followed the presentation regarding the Urban Forest Management Plan that will be developed by Mike and a consultant. The Commissioners will have the opportunity to be involved in the process to help update the codes and policies, possibly the subcommittee for Natural Systems. The Commissioners asked Mike to provide them with the Tree City USA report for 2016.

The meeting was opened for public comment and discussed how the city plans to get from the current the 19% of canopy cover to 30% by 2020. There was also a question of the removal of trees from Annie Wright School and that removing them was legal according to our current codes.

### **Environmental Action Plan, City Council Engagement – Lexi Brewer**

The Commission reviewed the EAP top priorities that they would like to discuss individually with the City Council Members. The list will be narrowed down to the top 5-8 and talking points will be developed with STC staff and chair. The goal will be to start meeting with the Council in August.

The Commissioners requested that staff look at alternative dates and times for the STC meetings. Staff will send out a request to get the Commissioners availability.


### **Public Comment**
