### **Subcommittee Updates and Council Meeting Debrief**

Commissioners felt that their meetings with Council Members to discuss priority actions for implementation of the Environmental Action Plan (EAP) were successful. As a result of their meetings, Mayor Strickland invited the Office of Environmental Policy and Sustainability to present about the EAP and Greenhouse Gas Inventory at a Study Session at noon on October 31<sup>st</sup> – Commissioners are encouraged to attend. Building on this success, the Commission should re-write their EAP priorities letter to Council, and should meet with Council Members again on this topic in the spring of 2018.

Josh Jorgenson reported that South Sound Transit will be investing in the Hilltop Neighborhood's infrastructure – including sidewalk corners and planting. More information can be found under the Public Works tab of the City's website.

- Participation in a brainstorm meeting in preparation for the South Sound Sustainability Expo on April 14<sup>th</sup>, 2018.
- Stakeholder involvement in the upcoming Urban Forestry Management Plan.
- Participation in the annual Washington State Department of Transportation Bicycle and Pedestrian Count Project, the data from which will be used for EAP reporting.
- Upcoming Bike Ride with City Council, hosted by Downtown On the Go.
- Green Tacoma Day volunteer stewardship events on October 14<sup>th</sup>.
- City-wide tree plantings happening through the City's Grit City Trees program.

- Discuss re-writing the EAP priorities letter for Council.
- Discuss the STC's required annual update to the Infrastructure, Planning and Sustainability Committee.
- Review Chrissy's draft letter to Council regarding the Tideflats Interim Regulations.
