## **Briefing Items**

1. <u>18-0223</u>

Eliminating Certain Authority Related to the Granting of Severance Payments [Bill Fosbre, City Attorney, City Attorney Office and Gary Buchanan, Director, Human Resources]

At approximately 10:05 a.m., Bill Fosbre, City Attorney, gave introductory remarks and provided an overview of eliminating certain authority related to the granting of severance. Mr. Fosbre described the purpose of the incentive, usage, employment agreement, approval process, what would not constitute without cause, provisions, and qualifications.

MOTION: Council Member Hunter moved to recommend the elimination of certain authority related to the granting of severance to the full City Council for consideration.

# 2. <u>18-0224</u> Modifications to Funds and Fees [Peter Huffman, Director, Planning and Development Services]

At approximately 10:09 a.m., Peter Huffman, Director, Planning and Development Services, gave introductory remarks and an overview of what is in the package and the agenda. Mr. Huffman presented the timeline of funds and fees from 2010, 2014, 2015, 2016, and 2017, including the fee study, revenue generation, process improvements, and the cost and time associated with the permit process. He presented stakeholder's input; financial policies, including principles, expenditure controls, cost recovery and revenue, fee adjustments and service levels, management of dedicated funds and reserve fund policies, and performance monitoring; fee code changes including Tacoma Municipal Code (TMC) 2.09 revisions, fee schedule, new single-family fees, and revisions to TMC 3.02 and TMC 2.19. He described the restructure of the enterprise funds, including the current and proposed funds, the new single family fees overview, next steps, examples, proposed phases I and II, and new home development fees compared to different jurisdictions. He reviewed on the Level-of-Service (LOS) and agreement with the Master Builders Association (MBA), including timeline involved from the first review to additional reviews, and the percentage of quality and time required to meet LOS. Mr. Huffman concluded on next steps and timeline involved.

Discussion ensued throughout regarding comparison to other jurisdictions, flat fees in comparison to valuation fees, next steps to the phase I adjustment fee schedule and timeline involved, clarification of involvement with detached accessory dwelling units, how new single-family fees will impact timelines, the accountability and committments of the City. Discussion continued on connections with the MBA and smaller builder associations, outreach to Pierce County Department of Labor, implementation timelines, adjustments, and fiscal impacts.
